Dear Governor Haley:

Since your state will hold an election for U.S. Senator on November 4, I want to remind you of the Senate requirements for certificates of election.

When the result of an election for United States Senator has been officially ascertained, federal law (2 U.S.C. § 1(a)-(b)) requires that a certificate of election must be signed by the Governor, attested to by the Secretary of State, have the seal of the state affixed and must be provided to the President of the Senate. If a state does not have a Secretary of State, the certificate must be signed by the highest state election official. Enclosed is a copy of Senate Rule II which contains the wording for the certificate. The language must be adhered to or the certificate will be rejected and returned to the state for re-certification.

Since the senator's term is to begin on January 3, 2015, when the new congress convenes, the original certificate must be delivered to the Secretary of the Senate well in advance of January 3rd. Heightened mail security measures at the Capitol and the need to ensure that election certificates will be received in a timely manner require that the certificate must either be:

1. Mailed via U.S. Postal Service certified/registered (use the option that does not require "Return Receipt Requested," as there is no one to sign) to the Office of Public Records, P.O. Box 77578, Washington, DC 20013-7578. Enclosed is a return label for mailing the document. It is advised that the mailing receipt be retained for proof of timely mailing; or
2. Hand-delivered to the Senate Office of Public Records, 232 Hart Senate Office Building, Washington, DC 20510. Because the delivery of sealed envelopes, boxes, or other containers is prohibited in the Senate buildings, the certificate should be delivered in an unsealed file folder.



RULE II

PRESENTATION OF CREDENTIALS AND QUESTIONS OF PRIVILEGE

- 2.1 1. The presentation of the credentials of Senators elect or of Senators designate and other questions of privilege shall always be in order, except during the reading and correction of the Journal, while a question of order or a motion to adjourn is pending, or while the Senate is voting or ascertaining the presence of a quorum; and all questions and motions arising or made upon the presentation of such credentials shall be proceeded with until disposed of.
- 2.2 2. The Secretary shall keep a record of the certificates of election and certificates of appointment of Senators by entering in a well-bound book kept for that purpose the date of the election or appointment, the name of the person elected or appointed, the date of the certificate, the name of the governor and the secretary of state signing and counter-signing the same, and the State from which such Senator is elected or appointed.
- 2.3 3. The Secretary of the Senate shall send copies of the following recommended forms to the governor and secretary of state of each State wherein an election is about to take place or an appointment is to be made so that they may use such forms if they see fit.

THE RECOMMENDED FORMS FOR CERTIFICATES OF ELECTION AND CERTIFICATE OF APPOINTMENT ARE AS FOLLOWS:¹

"CERTIFICATE OF ELECTION FOR SIX-YEAR TERM

"To the President of the Senate of the United States:

"This is to certify that on the — day of —, 20—, A— B— was duly chosen by the qualified electors of the State of — a Senator from said State to represent said State in the Senate of the United States for the term of six years, beginning on the 3d day of January, 20—.

"Witness: His excellency our governor —, and our seal hereto affixed at — this — day of —, in the year of our Lord 20—.
