SUMMARY OF PROPOSED USE HEARING

GENERAL REVENUE SHARING FUNDS

FISCAL YEAR 1980-81

Consistent with actions taken by the State Budget and Control Board at its November 7, 1979 meeting which gave tentative approval to 1980-81 budget recommendations pending the outcome of this hearing, Executive Director Putnam conducted a public hearing on possible uses of General Revenue Sharing funds in 1980-81 on Tuesday, November 13, 1979. Notice of the hearing, which was held in Room 202 of the Wade Hampton State Office Building at 10:00 a.m., was published in The Columbia Record on October 30, 1979. A copy of that notice is attached. Additional notice of the hearing was given to all of the media by the Governor's Press Secretary and to organizations concerned with the interests of senior citizens.

The hearing was attended by State Treasurer Grady L. Patterson, Jr.; Comptroller General Earle E. Morris, Jr.; Senate research staff member Fletcher Smith; and Donna K. Williams.

#### **PUBLIC HEARING NOTICE**

The State Budget and Control Board will hold a public hearing on the proposed use in fiscal year 1980-81 of general revenue sharing entitlement funds to be received by the South Carolina State Government pursuant to the State and Local Fiscal Assistance Act of 1972, as amended by the State and Local Fiscal Assistance Amendments of 1976.

As of September 30, 1979, there were no unappropriated entitlement funds in the Revenue Sharing Trust Fund. It is estimated that entitlement funds in the amount of \$31,000,000 will be received by the State Government during fiscal year 1980-81.

Interested citizens are invited to attend this hearing and to present written and oral comments and suggestions on the possible uses of general revenue sharing entitlement funds by the State Government in fiscal year 1980-81. Written comments also may be mailed to the Secretary, State Budget and Control Board, P.O. Box 12444, Columbia, South Carolina 29211.

This public hearing will be held at 10:00 a.m., Tuesday, November 13, 1979 in the Conference Room of the State Auditor's Office on the second floor of the Wade Hampton State Office Building, Columbia, South Carolina.
