Thank you for forwarding us the letter from Ms. Dottie Evans of Hopewell Senior Day Care Center, Inc. (Hopewell), regarding concerns she has with the Medicaid transportation services in Georgetown and Williamsburg Counties.


The Department of Health and Human Services (DHHS) competitively procured the services of two Brokers to administer the Non-Emergency Medicaid Transportation Program. The Brokers are responsible for contracting with transportation providers to transport Medicaid beneficiaries to Medicaid covered non-emergency medical appointments, including transportation to Adult Day Health Care Centers like Hopewell if the beneficiary resides outside a fifteen mile radius. Logisticare, Inc. is the Broker responsible for arranging Medicaid transportation for Medicaid beneficiaries attending Hopewell.

Mrs. Deirdra T. Singleton, our General Counsel, has been in regular contact with Ms. Evans to assist her in resolving her issues with Logisticare. Most recently, Logisticare provided Ms. Evans with documents for her to complete to become a Medicaid transportation provider to transport clients to her Adult Day Health Care Center. Mrs. Singleton has also discussed Ms. Evans' concerns with Logisticare representatives and they have met with Ms. Evans to discuss and resolve her transportation issues. We have told Ms. Evans to contact us if she has any other issues regarding this matter. We are committed to making certain Ms. Evans concerns are addressed.
