Hudson advised he located the victim by a truck on Willtown Road. Hudson placed the victim inside the bed of his truck (2014 Silver Chevy Silverado MEV567 SC) and transported him to the fire station. Sgt. Semlitsch responded to the fire station and notified CID. Deputies Tyner, Alsbrook, Turner, Jameson and Ragos responded to Willtown Road. The truck (2004 red Chevy Silverado DBF706 SC) was located on the side of the road. Deputies Mackey and Wilcox stayed at the fire station with Hudson and the vehicle. I responded to Willtown Road and the area was secured as a crime scene. A crime scene log was completed by Deputy Jameson. Sgt. Semlitsch also responded to Willtown Road. The truck had struck mailbox posts and was still on and in drive. Sgt. Semlitsch turned the truck off. The truck had several bullet holes in the rear, a shattered rear window, and what appeared to be blood inside the cab. Several bullet casings were located in the roadway. Deputies Tyner and Ragos check the area and nearby residences and were unable to locate any witnesses. The scene was turned over to CID. My body camera was activated during this incident.

AFFIDAVIT

Personally appeared before me, a magistrate of this County, one Detective W. Muirheid, who, first being duly sworn, deposes and says that:

ROBERT HENRY CAMPBELL JR.

did within this County and State on October 15, 2016 violate the criminal laws of the State of South Carolina in the following particulars:

MURDER

16-3-10

The affiant states that there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:

That on October 15, 2016 while in the area of Willtown Road and Ernestine Road Hollywood, SC 29449 in the County and State aforesaid, the above named defendant, **ROBERT HENRY CAMPBELL JR.**, did commit offense of **MURDER** in violation section 16-3-10 of the South Carolina Code of Laws, 1976 as amended, in that the defendant did willfully with malice and forethought while acting in concert with others did shoot at the victim, Wayne Bennett, that later died as the result of a gunshot wound to the back of the head.

On 10/15/16 at or around 1805 hrs the Charleston County Sheriff's Office (CCSO) responded to 6488 HWY 162 Hollywood, SC in reference to Wayne Bennett suffering from an apparent gunshot wound to the head. Upon arrival CCSO discovered that the shooting actually occurred at a different location on Willtown Road Hollywood, SC. Bennett was transported to MUSC where he was pronounced dead.

On the same night CCSO located Bennett's truck on Willtown Road off the roadway and stopped. The rear window was partially shot out, and when the vehicle was discovered it was still on and in drive. Several .40 caliber shell casings were located in the street on Willtown Road several hundred feet behind where Bennett's truck came to rest.


A witness to be named later advised that they saw the defendant, Robert Campbell, in possession of a firearm and shooting at Bennett's truck as it was attempting to leave the scene. A witness to be named later described the area that the defendant was standing during the shooting as the area where the .40 caliber shell casings were recovered.

During the first few days of the investigation Detective Muirheid received several tips advising that Robert Campbell was a shooter during the incident, and on 10/20/16 Detective Muirheid met with Campbell and he confirmed that he was at the incident location during the incident, and indicated that it was in the area that the shell casings were located.

All this was done against the form of the Statute and against the peace and dignity of the State of South Carolina. Det W. Muirheid is a witness and witnesses to be named later to prove the same.

The affiant states that there is probable cause to believe that the defendant named above did commit the crime(s) set forth, and that such probable cause is based on the following facts:

That on October 15, 2016 while in the area of Willtown Road and Ernestine Road Hollywood, SC 29449 in the County and State aforesaid, the above named defendant, **ROBERT HENRY CAMPBELL JR.**, did commit offense of **POSSESSION OF A FIREARM DURING THE COMMISSION OF A VIOLENT CRIME** in violation of section 16-23-490 of the South Carolina Code of Laws of 1976, as amended in that the defendant did willfully, unlawfully and feloniously, possess a firearm during the commission of murder.


