Haley,

I see his point; the way Commerce reports membership on the committee, the "gubernatorial appointments" would be inclusive of 2 legislators – Sen Davis and Rep Murrell Smith, bringing the membership to 4. Looking into this though, the structure Commerce reports is a little off from the structure of the Executive Order, which we will address in the next day or two. Overall, though, here's the goal as I see it:

- 12-15 members tied to the MBTF organized as a sister organization or subcommittee
- Roughly equal legislative, private sector, executive branch split
- Private sector pulled from current membership of MBTF
  - o Bill Bethea
  - o 3 – 4 other Gubernatorial Appointments
- Executive Branch would be directors of relevant entities, chosen from some mix of the following list to reflect employment, special needs related to disability and PTSD, and community integration post-separation and post-deployment:
  - o Department of Mental Health

- Department of Disabilities and Special Needs
- Department of Employment and Workforce
- State Veterans Affairs
- Adjutant General
- Correctional or Law Enforcement. Prosecution Coordination Commission feels right here, but I'm open to suggestion.
- Legislators would represents military communities and military interests
  - Tom Davis (Parris Island/Beaufort Aviation)
  - Murrell Smith (Shaw)
  - James Smith (Veteran/Guard and Reserve Component)
  - Senate – Currently Vacant

12 works out well with legislative and private sector at 4 each – the balance may tip based on the number of agencies we choose to represent with committee membership, as opposed to just having the agency present information. We could also pull off the disability/mental health agencies entirely and accomplish that representation by appointing members of that community or credible non-profits/providers. This would occupy gubernatorial appointments and keep the overall size of the committee manageable.
