RE: South Carolina Medicaid's Medically Fragile Children's Program

Dear Ms. Emma:

This letter is in response to your letter dated October 1, 2008 requesting that we extend the current deadline of December 31, 2008 for the Medically Fragile Children's program for an additional six months.

We understand that the State has submitted the 1915 (c) Medically Complex Children's HCBS waiver and the State plans on operating the program through a combination of a 1915(a) and (c) waivers. However, to date we have not received a current contract between the State and the contractor(s) who will be providing these services. We understand that the extension of the deadline would allow the State to develop a provider service system, modify your information technology systems, and transition the children from the existing program into the new 1915(a)(c) combination home and community based waiver. We also understand that these purposes are important to the success of the program; however we cannot approve the extension until we are in receipt of an approvable contract. Since it is the contract that will ultimately pay for all of the services, it is important that the State submit the contract(s) to us as soon as possible.
