Katherine,

We have been working closely with the county. I was told there was a \$4million dollar threshold but homeowners have contacted FEMA directly and they have been told by FEMA that even if two houses had damage, there is a federal grant out there to assist them. There were more then two houses affected. Several houses have \$80,000 plus worth of damage and cannot get any loans to help with repairs.

FEMA said they had to apply for the grants with the President. They would like the governor to help them do

that. Is there anyone that might know more about the grants and if that is even a possibility? We really need to try to do something for a few of these homeowners. They have basically been left homeless and have no way to recover their property.
