Thank you for your time this morning. First let me state, it is so nice to know that as a part of Governor Haley's Executive Staff you do take time to hear the voice of the people, and help them. For helping me to get an Open Door Appointment, I am so appreciative. After speaking with you this morning you asked that I email you regarding my agenda.

1. IDEA: Individuals with Disabilities Education Act

The Individuals with Disabilities Education Act (IDEA) is a law ensuring services to children with disabilities throughout our nation! It governs how our state and public agencies provides early interventions, special education and related services to more than approximately 6 million infants, toddlers, children and youth with disabilities (Reference: [www. ncl.org](http://www.ncl.org))

2. SEED: SC Standards for Evaluation & Eligibility Determination

The SEED document is designed to be a companion to SC State Board of Education regulation 43-243.1 (Criteria for Entry into Programs of Special Education for Student with Disabilities).

The SEED and regulation 43-243.1 are the states interpretation and guidelines for the federal IDEA.

I have heard that The SEED is currently under revision. There are 13 eligibility categories: (specific learning disability, intellectual disability, emotional disability, other health impairment, autism, developmental delay, traumatic brain injury, speech/language impairment, orthopedic impairment, vision impairment, deaf and hard of hearing, deaf blindness, and multiple disabilities.

3. " Free Appropriate Public Education" (FAPE) is an educational right of children with disabilities in the United States that is guaranteed by the Rehabilitation Act of 1973 and the IDEA.

The barriers that I see in our educational system appear systemic in nature and seem to be isolated around two

main factors: Medicaid as an organization, and as it relates to evaluations. Second, Response To Intervention in the schools. If we are going to ensure that IDEA and The SEED document work cohesively together to ensure FAPE, we need to talk!!
