The unveiling is at 11:30am on Monday at St. Stephen Middle School. This program provides supervised Wi-Fi accessibility on select Berkeley County school buses to help students further their academic pursuits while on lengthy commutes. In February, 28 Berkeley County school buses that support six Title I Schools - Cross Elementary, Cross High School, JK Gourdin Elementary, St. Stephen Elementary School, St. Stephen Middle School, Timberland High School- were wired with WiFi. More than 1,700 students from those schools, which cover the St. Stephen and Cross communities, received backpacks with Chromebooks to participate in RSH. At the end of the school day, teachers board the bus and assist students with their homework or participate in coding activities.
