M I N U T E S

Mr. Wiles and the incumbent members of Council were sworn in by the Honorable Judge Walter T. Cox, Jr.

Mr. Poore called the meeting to order and Mr. Wright gave the invocation.

On the motion of Mr. Rhodes, seconded by Mr. Gerrard, Council voted unanimously to approve the minutes of the December 19, 1978 meeting as mailed.

Mr. Dan Hook stated that he was available to answer any questions concerning the 1977-78 annual audit.

Mr. Hehn discussed sealed bids for several items. On the motion of Mr. Rhodes, seconded by Mr. Wright, Council voted unanimously to split the County asphalt purchases for the next three months between Pickers and Tribble Construction Companies at \$16.15 per ton. On the motion of Mr. Wright, seconded by Mr. Wiles, Council voted unanimously to award the bid for one Asphalt Distributor to International Harvester for \$23,611.68. On the motion of Mr. Gerrard, seconded by Mr. Wiles, Council voted unanimously to award the bid for 4 dump trucks to Clinkscales Chevrolet Company for \$46,750.92. Mr. Hehn stated that no bids had been received for the roller and on the motion of Mr. Gerrard, seconded by Mr. Rhodes, Council instructed Mr. Hehn to take bids on the roller again.

Mr. Hehn advised Council that the law requires Anderson County to collect Front Foot Assessment charges in Homeland Park. Mr. Hehn stated that Homeland Park had presented an invoice in the amount of \$1,378.29 which reflects the cost of billing Homeland Park residents for their 1978 Front Food Sewer Line Assessments. On the motion of Mr. Wright, seconded by Mr. Gerrard, Council voted unanimously to reimburse Homeland Park in the amount of \$1,378.29 from the Contingency Fund.

Mr. Walters recommended Council accept certain roads in Oakwood Estates Subdivision which have been paved for 1½ years to date. On the motion of Mr. Wright, seconded by Mr. Gerrard, Council voted unanimously to accept only those roads in Oakwood Estates Subdivision which have been paved for 1½ years.

Mr. Lusk presented an Ordinance for third reading authorizing the transfer of the Cablevision franchise from Anderson Cablevision to Booth American. On the motion of Mr. Wright, seconded by Mr. Gerrard, Council voted unanimously to adopt the Ordinance on third reading.

Mr. Poore stated that a Public Hearing was next on the agenda to receive citizens comments concerning the proposed issuance of General Obligation Bonds for repair of existing County roads. There were no comments.

On the motion of Mr. Rhodes, seconded by Mr. Wiles, Council voted unanimously to amend Article II of the Road Bond Ordinance to specify a 18 year pay off instead of 20 years to change the date of the issue, and to make such other changes as are reflected in the Ordinance.

On the motion of Mr. Rhodes, seconded by Mr. Gerrard, Council voted 3 to 2 to delete Section V of the Road Bond Ordinance which had provided that County Council would recommend to the Supervisor which County roads would be repaired. Supervisor Poore, Mr. Rhodes, and Mr. Gerrard voted for the motion. Mr. Wright and Mr. Wiles voted against the motion. The amendment also provided that the Ordinance:

"For The Issuance And Sale of Five Million (\$5,000,000.00) Dollars General Obligation Bonds of 1979, Of Anderson County, South Carolina; To Prescribe The Conditions Under Which The Bonds May Be Expended, To Provide For The Payment Thereof, And Other Matters Relating Thereto, Be And Hereby Is Approved As Amended."

Copy of the above referred to Ordinance, approved as amended, attached hereto and hereby is made a part of these minutes and was called for first reading as amended.

On the motion of Mr. Rhodes, seconded by Mr. Wright, Council voted unanimously to name Mr. Gerrard as Vice-Chairman.

Mr. Campbell again advised Council that they should make every attempt to place County Public Service Employees on the permanent County payroll.

On the motion of Mr. Wright, seconded by Mr. Gerrard, Council voted unanimously to adjourn at 10:10.
