Prior to being hired at Shaw Nuclear I knew for a fact that cyber securing and or securing the nuclear power facilities was going to be virtually impossible because the United States Nuclear Regulatory Commission as well as the nuclear corporations were not aware that these systems had already been hacked. And to exacerbate the already monumental oversight they never consulted the hackers and they weren't knowledgeable of the fact that a percentage of the technical work force was working using bogus credentials. In 2009 the Islamic Jihadists were well aware of these tactics of infiltrating corporations by fabricating fake credentials and there is evidence that they are actively in the process of infiltrating nuclear.

On Friday, October 7th, 2016, just a few days ago, two white men came to my home as I was walking into my garage and assaulted me. They clearly told me that I should not ever attempt to hire an attorney again and to publish the manuscript would be a death wish. Their visit cause me to go to the Chester County Hospital's emergency room and a doctor's visit the following Monday. Prior to this visit I had already been visited twice since I was released from Elkton Federal Prison. One of the visits cost me a tooth. About three weeks earlier I had made an appointment with Creighton Coleman and attorney (also SC Senator) practicing in Winnsboro, SC and after Coleman refused to represent me and as I left his office I was immediately approached by two men as I was about get in my vehicle. They told me the following: "We told you, no attorneys".

I have attempted to bring this matter to the attention of FBI and in the past I have even worn a wire for the FBI; specifically **Special Agent Jamin Purvis** of the Charlotte Office when the office was located at 400 South Tryon Street but Shaw Nuclear informed the FBI that I was a threat to their corporation and I was arrested. After I was released from Elkton Federal Prison, I visited **SC State Law Enforcement Division** and met with Major Weir and SLED ignored my request for help. If it were not for the videos which I have given my family members to go to the media with if I were to end up dead, I would already be dead. The problem is, I was offered money to keep quiet and not publish the manuscript but they refused to invite a representative of the **United States DOJ** to the table.

My family members and other relatives associated with the University of South Carolina, Benedict College, Allen University, South Carolina State College and Winthrop University have expressed an interest in organizing a protest which would take place in Columbia, SC, in order to bring this matter to the attention of the media and rectify this injustice. If this were to go public in that manner it would virtually collapse any and all credibility the American people have in the United States Justice system and the possibility of a national revolt would be inevitable. The United States Department of Justice, which has the reputation of being the epitome justice and righteousness, would be categorized no differently than that of law enforcement of Ferguson, Missouri prior to their incident.

National security of the United States of America would be portrayed as literally non-existent because their mindset would immediately revert back to post 9/11, but this time it would be nuclear because it would be revealed that a federally convicted felon with virtually no technical training was allowed to be hired using fake credentials in a highly sensitive nuclear power plant design environment where I was given access to everything pertaining to nuclear power plant design. The American people would immediately demand all nuclear to be brought to a screeching halt, sanitized from a human resources perspective and some mechanism would have to be put in place to guarantee the safety of nuclear. Our citizens would be catapulted into a state of unrest which could metastasize into an unimaginable violent period in America's history.

Proposed Solution

- a. The United States Department of Justice provides outside legal representation me and a representative from DOJ also is there.
- b. The corporations which would be liable under civil conspiracy laws be represented, which would include but not limited to the following: the Shaw Group, Chicago Bridge & Iron, Duke Energy, South Carolina Electric & Gas, the Southern Company, Progress Energy, Westinghouse and Toshiba.
- c. The aforementioned corporations purchase all publishing rights to the manuscript.

d. I walk away with charges dropped and absolute immunity and not mention how terrible national security is relating to nuclear power in the United States.

The United States Government has everything to lose and nothing to gain by refusing this proposal.

The aforementioned nuclear corporations would collectively lose more than \$500,000,000,000 (a half trillion dollars) if this were to go public.
