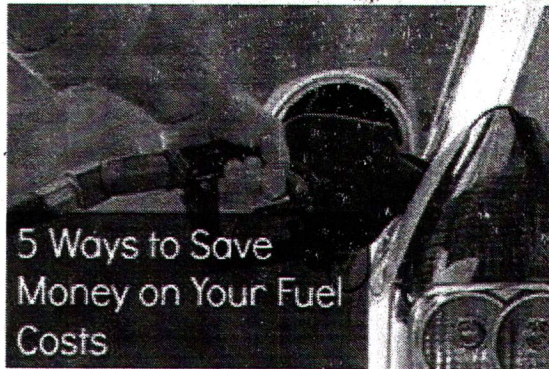
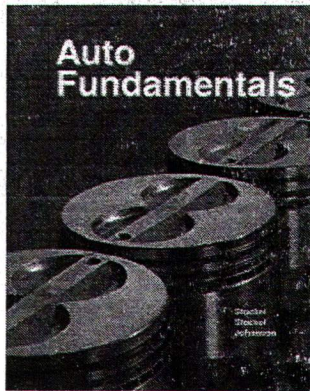

And in the January, 1980 issue of Reader's Digest (30 million copies in January, 1980), they printed two articles documenting that another oil shortage in America claimed caused by Iran was actually a hoax engineered by the U.S. Republic. In case of emergency, you can use Coleman or other makes of stove and lantern fuel if you will mix with 50% gasoline.

FUEL OIL ACTIVATOR:

Napthalene 100 Parts, Anthracene 7-1/2 Parts, Phenanthrene 2 Parts. Add 30 grams of the above mix to each 5 gallons of Fuel Oil to increase heating efficiency.

If you use more than a half & half mixture of an extender, be sure to put some brand name gasoline additives in your tank. You can buy these at any auto parts or department store auto parts department.

Anti-Knock Agent For Gasoline. Add 4 cc of the following mixture to each gal. of gasoline: Kerosene 40 Parts, Iron Carbonyl 40 Parts, Diglycol Stearate 20 Parts.

RACING FUEL:

Anhydrous Alcohol 91>8 Parts, Benzine 8.2 Parts

By enlarging the fuel jets in your carburetor by 40%, you can run your car on straight alcohol or alcohol and water instead of gasoline. A car can even run on 60% alcohol – 40% water mixture, but a ratio of 70% on upwards is best. You can run an oil furnace on alcohol or alcohol and water by increasing the size of the heater's fuel nozzle about 25% - a 90 degree nozzle works best – and then decrease the air adjustment until the flame is burning smoothly. It will burn with a clean, hot, almost invisible yellow flame. My knowledge of history has often made me deadly in legal issues and I win against big legal sources because I knew my legal history in key areas well!

I can make myself popular with some sources and unpopular with others when I tell the truth what real law is in America. Pro-Southern law: The Confederate States never legally surrendered to the Union because only a general in the field named Gen. Robert E. Lee surrendered. The Confederate Constitution modeled after the U.S. Constitution in many

areas required the Confederate Congress to authorize surrender of the nation and the Confederate President to sign the surrender papers. Never happened because Abe Lincoln was a lawyer himself and staged how the surrender would be handled. If he only accepted a military surrender of a Confederate general, then under law this was treated as a military surrender of a military insurrection in America. If he accepted the surrender of the Confederate Congress and President, then he was extending legal recognition that the Confederate States of America had been legally an independent nation under international law until they surrendered.

The Constitution of the State of South Carolina has this as the legal oath of the officials, etc. of the South Carolina Government: "I do solemnly swear (or affirm) that I am duly qualified, according to the Constitution of this State, to exercise the duties of the office to which I have been elected, (or appointed), and I will, to the best of my ability, discharge the duties thereof, and preserve, protect, and defend the Constitution of this State and of the United States. So help me God." Since they have sworn to uphold as law all of the U.S. Constitution as binding law over South Carolina as well, then we have this legal sleeper that was never cancelled by constitutional amendment: U.S. Constitution, Article I, Section 10: "No State shall make any Thing but gold and silver Coin a Tender in Payment of Debts;". F. Tupper Saussy in his book "The Miracle On Main Street" quotes from the constitutional convention that this passage on gold and silver coin was passed by Judge Roger Sherman and his allies so the U.S. Republic created by the U.S. Constitution could never legally pass laws to make printed currency or bank checks ever made legal money or legal tender under legal authority in America. Thomas Jefferson said of Judge Roger Sherman: "Roger Sherman was a man who never said a foolish thing in his life." The Americans who fought the American Revolution had been burned by the "Continental" as the revolutionary currency was called which afterwards became worthless and triggered off the American saying "As worthless as a Continental!" They didn't want paper currency again in America nor bank checks which was basically the same thing as not backed by either gold or silver banking. Basically under the legal terms of the U.S. Constitution, I have never been paid any legal tender in South Carolina under legal terms required of South Carolina under the U.S. Constitution as applied legally to South Carolina. Under law I have yet to receive any legal tender which is the fancy legal term for lawful or valid money under law.

I could easily push this as a legal issue since lawyers lack integrity towards the U.S. Constitution both federal and state level and even when promoted to judges they are not going to uphold certain sections of the U.S. Constitution as law which means that legal integrity in the legal profession is basically a legal joke and law is done by whim and not by legal terms of the U.S. Constitution. It is like the old joke. Two men walk through a graveyard site and one man notices the tombstone and reads it aloud: "Here is buried a lawyer and an honest man!" The other man then replied, "Wow, I never knew that they buried two men in the same grave!" This joke is satire and a comment on the legal integrity in the legal field in America both federal and state. Automatically I owe nothing in sales tax, etc. under the real terms of the U.S. Constitution to South Carolina.

However, for the sake of peace as why spend years in courts on issues that the courts do not want to rule upon with legal integrity, I pretend that the paper currency and bank checks that I receive are legally money which they are not. My revenues are small for this business as federal operatives stole \$525,000 from me and threatened me with murder if I tried to stop them and I have witnesses to this \$525,000 theft of money which was intended to block me from reestablishing in America my father's Vatican and Soviet Union endorsed great food discovery from being produced in America once more. Starting with 1 cent to my name to begin a business operation with again and a few videos to sell at a flea market to raise a few dollars, this is what I had basically after this \$525,000 was federally stolen from me in a very total criminal violation of law but no courts would prosecute the federal side for this. I have a witness who saw me start from this tiny beginning. I built up to where I could generate occasional sales for my listed business in South Carolina, but also arranged loans which I would repay once I turned the tide and I had the upper hand in finances again. The sales covered a few small expenses of business costs, etc. and the loans were secretly to arrange so I would have large finances later on for my father's Vatican endorsed industrial food process and could reestablish my father's trade secret industrial food process again in America. Keeping it blocked as information from federal hackers, and other criminals working for Obama in the White House, large financial commitments have been made that should become reality down the road. One commitment is for up to \$500 million to get this food industry started in America again. Other commitments are available too once the moment is right and some commitments are potentially large sums to get the food industry going again in America. My father had a setup maybe worth \$5 million when operational and supplied maybe up to 2,100 to 2,300 bakeries across America. Federal legal trickery destroyed his business which was self-

supporting with a good base of wholesale customers nationally.

Our scoundrels in the Revenue Department of the South Carolina Government try to claim that loan money received to promote the big side of this business picture is income are contrary to standard law which says that loans are not income. Also, people ordering from other states to South Carolina are not required to pay SC state sales tax under standard law and also Article I Section 9 of the U.S.. Constitution says: "No Tax or Duty shall be laid on Articles exported from any State." The U.S. Constitution forbids South Carolina from treating loans as income and taxing articles sent to other states. I get orders from South Carolina, then they can be pressed to pay SC sales tax, but not orders from other states.

I enclose a sheet of legal rights of Americans I compiled so Americans will know that they have legal rights under federal laws and U.S. Supreme Court decisions. I can sue the daylights out of the Governor of South Carolina, members of the South Carolina legislature, South Carolina judges, and officials and personnel of the South Carolina Department of Revenue. This legal sheet of legal rights is enclosed. I report as sales what comes in as ordinary orders from other states which almost all my orders come from and as sales taxed sales when they come from South Carolina which is standard law. When I receive loans to back this pending food industry needed so badly by the American economy to boost and skyrocket it in national prosperity, they are not reported as income which is correct law for America. You invent fraudulent figures to try and extort out of me which I do not owe you. This is a criminal act by the officials, personnel, and agencies of South Carolina as this is a version of an attempted legal frame-up using fraudulent claims and falsified law to try and make look like a criminal act what is legal, valid, and no criminal act under valid law in America. I am legally provoked and expect you to practice correct law henceforth or else face legal actions that you will regret once I start them.

I have posted probably around 600 to 800 national reports on www.nesaranews.blogspot.com for the last three years or so. I write under the pen name of Erasmus Of America and apparently millions of people have read my national reports during that time. I have received comments from people all over America and from foreign nations who strongly like my reports and once we pass my proposed Omni Law in America, I have people in other nations who want to join us politically then and make this a worldwide movement to pass this same basic referendum law in all nations of the world as a freedom movement for all

of mankind. Many times I have talked with wealthy people and they say that they have read my national reports, like them very much, and I have friends and supporters all across America. I make sense to the people! I have publicized the Vatican endorsed industrial food process of my father and many other things talked about in this legal answer to you. The F.B.I. keeps quiet as they know I tell the truth and it would be legal suicide to try and legally interfere with me when I am legal in what I do. Actually probably most of the F.B.I. secretly agrees with me but can't say that publicly for career reasons. Just talking reality!

I was supposed to be doing business promotions today. Instead I am writing this to you as it is required. I do not tolerate my legal rights to be violated by you or anyone else! Don't try to provoke me. I have not made a final decision yet whether South Carolina gets one of my likely four or five regional food distribution centers once it is time to set them up. You act as a decent civilized government, things calm down between us. Try to be smart aleck with tongue-in-cheek actions and Georgia or West Virginia gets the giant distributor center when I set them up instead of South Carolina. I am hoping by two years to have them being built across America.

As I am more of a historian than you would be, read the Address Of The People Of South Carolina, Assembled In Convention, To The People Of The Slaveholding States Of The United States. It documents how the federal government was taxing by tariffs the Southern States to where it threatened to bankrupt the entire South and most of this money went from the South to finance and set up industry in the Northern States. It was the mast theft of money from the South to the North using Wash., D.C. as the front which triggered off the secession of the Southern States from the Union, not slavery. C-367 (Rev. 7/22/15) 6318

"People of a State are entitled to all rights which formerly belonged to the King by his prerogative." Lansing v Smith, (1829) 4 Wend. 9, 20. Prerogative means "Exclusive right: a distinctively superior advantage."

"It is true that at (English) common law the duty of the Attorney General was to represent the King, he being the embodiment of the state. But under the democratic form of government now prevailing the People are King so the Attorney General's duties are to that Sovereign rather than to the machinery of government." Hancock v. "Search And Seizure Manual for Law Officers, page 16: "The loss of evidence isn't the only bad consequence of an officer's error in search and seizure. The officer may also be prosecuted by the US Department of Justice for depriving the Citizen of his Rights and may be sued in the federal district court. Juries have awarded Citizens up to \$250,000.00 for unlawful searches and seizures. This means that the officer may be laying his house, car and savings account on the line when engaging in unwarranted searches and seizures."

18 USC, Criminal Code, §241 Conspiracy Against Rights of Citizens: "If two or more persons conspire to injure, oppress, threaten or intimidate any citizen in the free exercise or enjoyment of any right or privilege secured to him by the Constitution or laws of the United States, or because of his having so exercised the same;...They shall be fined not more than \$10,000 or imprisoned not more than five years or both." Nothing here states that IRS agents, FBI agents, state police, etc. are exempt from this federal criminal law!

Supreme Court: Bivens v. Six Unknown Agents, 403 US 388, 29 Led2d 619, 91 SCt 1999 (1990): When a government agent acts in an unconstitutional manner, the agent as of then becomes personally liable for monetary damages.

Stokwitz v. US: Taxpayer alleging unlawful seizure and subsequent use of acquired tax information can then pursue legal remedy through a Bivens suit or other tort action.

Hollingshead v. United States 85-2 USTC 9772 (5th Cir. 1985), ruled, 26 IRC Sec. 7421 is a Waiver of sovereign immunity by the government for a Citizen now claiming that his or her property has been subjected to a wrongful levy.

Supreme Court: Blackledge v. Perry, 417 US 21, 40 Led 2d 628, 94 SCt 2098 (1974), Guan v. Dergurgur, 800 F2d 1470 (9th Cir. 1986): It is an unconstitutional deprivation of due process of law when the government penalizes a citizen merely because he or she has exercised any protected statutory or constitutional right.

In Bothke v. Flour Engineers, 713, F. 2d 1405 (1993) the U.S. Court of Appeals ruled that, when a taxpayer informs an IRS agent that he believes that there is an error in assessment and the agent still continues levy action, without first determining the merit of the taxpayer's argument, such agent loses his immunity from a suit.

26 USC 7214 (a) UNLAWFUL ACTS OF REVENUE OFFICERS OR AGENTS. Any officer or employee of the United States when acting in connection with any revenue law of the United States and violates any section of this act as to criminal or wrong doing, shall be fined not more than \$10,000 or imprisoned not more than 5 years, or both upon conviction by the court.

Meriwether v. Coughlin, 879 F2d 1037 (2nd Cir. 1989): When an official has actual or constructive notice of unconstitutional practices and fails to act in "deliberate indifference," then supervisory liability may be imposed under Title 42, Sec. 1983. He can be sued!

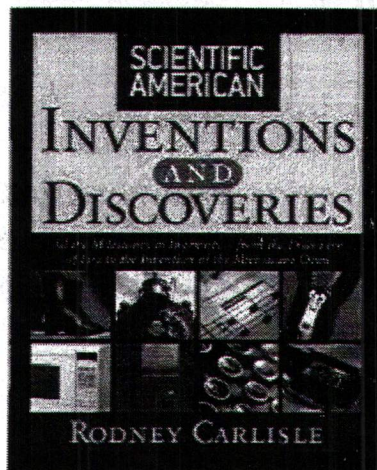
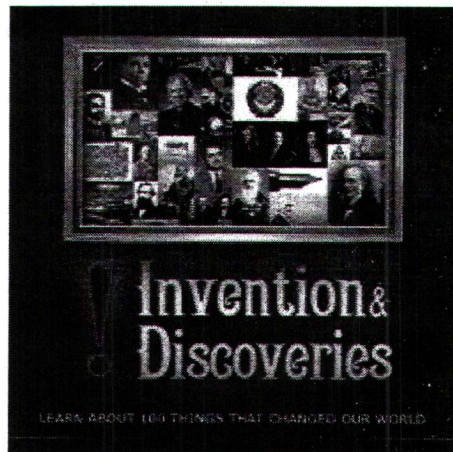
