1. CALL TO ORDER

8. CONTINUED BUSINESS

a. Discussion Regarding Physical Therapy and Animal Therapy

Ms. Ellis Witherspoon discussed a letter sent to the board from Ms. Williams in relation to Animal Therapy. Ms. Ellis Witherspoon stated the Veterinarian Board is opposed to Physical Therapist performing therapy on animals unless they are under the jurisdiction the Veterinarian Board. Mr. Ervin stated the Federation of State Board for Physical Therapist and the Federation of Chiropractors and Veterinarian Boards had developed a draft of a collaborative practice statement. That statement include language a Physical Therapist can participate in animal therapy but cannot hold themselves out as a Physical Therapist while engaged in performing therapy. At this time the practice act would not allow a therapist to practice animal therapy because the language states human beings.

b. Peer Reviews

Ms. Reynolds stated the Board could not assist in Peer Reviews because the statues do not allow the Board involvement in peer reviews. Ms. Reynolds stated there are some boards that that have in their statutory requirements that they can do peer reviews. Peer reviews done by the board would be beyond their scope of authority.

c. Clinical Question Regarding Sutures/Med Line/Drain Removals

Ms. Ellis Witherspoon brought to the board's attention a question that was sent to the board referencing whether or not a physical therapist could remove sutures, med lines and drain removals in an outpatient settings? Mr. Ervin stated to do these procedures the individual should be trained and follow facility policy and protocol. Ms. Ellis Witherspoon stated that an individual should have proper training and an educational background to perform these procedures. The board requested Ms. Ellis Witherspoon send a response to the inquirer and include that information.

d. Provisional License for Applicants Completing Coursework

Ms. Reynolds stated the Board continued to experience problem with a school out of state that was licensing their students prior to the degrees being conferred. The individuals would make application for licensure in South Carolina without the conference of a degree or work experience. Ms. Reynolds stated in the minutes dated July 11, 2002; Ms. Harvey - Cartledge addressed this issue to the board. Ms. Cartledge stated the Statutes allowed the C-20 to be used for the purpose of testing only and it could not supercede the statutory requirements of a transcript showing the conference of a degree before new graduates can be issued a license.

e. Physical Therapy Referrals for Services After 30 Days

Ms. Harvey-Cartledge stated after 30 days the Physical Therapist will need a refer from a licensed medicinal doctor to continue treating a patient. Mr. Schmidt stated the issue had come before the board on several occasions from the Chiropractor Association.
