Your November 12, 2009 e-mail to the Director's Office was forwarded to this Office for a response. The South Carolina Department of Health and Human Services (SC DHHS) was not directly involved in the procurement of the technology and services for the development of SCHIEX. SC DHHS contracted with the South Carolina State Budget and Control Board (B&CB) through their Office of Research and Statistics (ORS) initially for the development of an electronic personal health record and, subsequently for the development and maintenance of SCHIEX.
