At the request of an adjoining owner, an investigation was made and it was determined that the right of way was no longer needed and could be relinquished. Therefore, a gratis quitclaim deed conveying approximately 0.61 acres of land to P. Clifton Harper was executed on July 11, 1995.

2. File 23.246A - U.S. Route I-85 - Greenville County

During acquisition of right of way for construction of improvements to U.S. Route 25 Business in Greenville County, the Department acquired right of way by Right of Way Easements dated October 21, 1953 from Etta H. Orders, November 11, 1953 from John D. Spence, Jr. and December 9, 1953 from W. M. Hughes under File 23.358.

At the request of an adjoining owner, it was agreed in the negotiation for additional right of way of Relocated U.S. Route 25 that the excess property could be relinquished as part of the settlement. Therefore, a gratis quitclaim deed conveying approximately 0.24 acres of land to Mrs. Firecracker, Inc. was executed on July 11, 1995.

3. File 37.532 - U.S. Route 123 - Oconee County

During acquisition of right of way for construction of improvements on U.S. Route 123 in Oconee County, the Department acquired right of way by Condemnation Notice dated December 10, 1955, from S. M. Bibb and by Deed to Right of Way dated January 7, 1956 from Doris T. Brock and Annette S. Brock under File 37.357.

At the request of an adjoining owner, an investigation was made and it was determined that a portion of the above right of way was no longer needed and could be relinquished. Therefore, a quitclaim deed conveying approximately .378 acres of land to Edwards Land Management, Inc. was executed on July 14, 1995, for a consideration of \$2,500.00.

4. File 10.646 - Road S-770 - Charleston County

During acquisition of right of way for construction of improvements on S.C. Route 642 (Dorchester Road) in Charleston County, the Department acquired right of way by Letter dated 1957, from the Department of Public Works under File 10.443.

At the request of an adjoining property owner, an investigation was made and it was determined that a portion of the above right of way was no longer needed and could be relinquished. Therefore, a quitclaim deed conveying approximately 5,532 square feet of land to New Zion Reformed Methodist Union Episcopal Church was executed on July 18, 1995, for a consideration of \$3,485.00.

5. File 42.146A.1 - Route I-85 - Spartanburg County

During acquisition of right of way for construction of improvements on Route I-85 in Spartanburg County, the Department acquired right of way by Titles to Real Estate dated March 26, 1987, from James T. Duncan and Nell Norrie Duncan under File 42.128A.

At the request of an adjoining property owner, an investigation was made and it was determined that the above right of way was no longer needed and could be relinquished. Therefore, a quitclaim deed conveying approximately 1.2 acres of land to Grace A. Jolly and Roscoe B. Jolly was executed on July 19, 1995, for a consideration of \$2,000.00.

6. File 23.669 - U.S. Route 25 - Greenville County

During acquisition of right of way for construction of improvements on U.S. Route 25 in Greenville County, the Department acquired right of way by Deed dated May 14, 1975, from John M. Dillard under File 23.669.

At the request of a Greenville City official, it was agreed that a Title to Real Estate could be done to supersede the Title to Real Estate dated July 3, 1986, which has been lost or misplaced, and was never recorded with the Greenville County RMC Office. Therefore, a Title to Real Estate conveying approximately .04 acres of land to Charles C. Fowler, his Heirs and Assigns was executed on July 19, 1995, for a consideration of \$250.00.

7. Town of Wagener - Road S-1474 - Aiken County

During acquisition of right of way for construction of Road S-1474 in Aiken County, the Department acquired right of way from A. L. Corbett, by Title to Real Estate dated June 20, 1987 and from O'Neal Miller by Title to Real Estate dated June 22, 1973, under MSC File 78 & 78.1.

At the request of a Town of Wagener official, it was agreed that a Title to Real Estate could be done superseding the Title to Real Estate dated August 21, 1986, which cannot be located and was never recorded with the Aiken County RMC Office. Therefore, a Title to Real Estate conveying approximately 1.99 acres of land to the Town of Wagener was executed on July 31, 1995.

8. File 10.230A - S.C. Route 30 - Charleston County

During acquisition of right of way for construction of improvements on S.C. Route 30 (James Island Expressway) in Charleston County, the Department acquired right of way from American Service Corporation of South Carolina, by Condemnation Notice dated October 21, 1987, under File 10.230A.

At the request of an adjoining owner, an investigation was made and it was determined that a portion of the above property was no longer needed and could be relinquished. Therefore, a quitclaim deed conveying approximately 0.13 acres of land to Ann E. Smith, Jeannette E. Reese, Mary E. Staats and Daniel W. Ellis, Jr. was executed on July 31, 1995, for a consideration of \$3,640.00.

9. File 32.761/40.147A - Route I-26 - Lexington County

During acquisition of right of way for construction of improvements on Road S-671 (Piney Grove Road) in Lexington County, the Department acquired right of way from Baker and Baker, a South Carolina General Partnership, by Condemnation Notice dated May 11, 1993, under File 32.761/40.147A.

At the request of an adjoining owner, an investigation was made and it was determined that a portion of the above property was no longer needed and could be relinquished. Therefore, a gratis quitclaim deed conveying approximately 1.15 acres of land to Baker and Baker, a South Carolina General Partnership, was executed on July 31, 1995.

10. File 39.579 - S.C. Route 93 - Pickens County

During acquisition of right of way for construction on S.C. Route 93 in Pickens County, the Department acquired right of way from W. L. Merck, by Deed dated February 21, 1948 and from J.D. Vickery by Deed dated December 4, 1947, under File 39.579.

At the request of Pickens County Officials, an investigation was made and it was determined that a portion of the above right of way was no longer needed and could be relinquished. Therefore, a gratis quitclaim deed conveying approximately 0.24 acres of land to Pickens County was executed on July 31, 1995.

11. File 8.635 - U.S. Route 176 - Berkeley County

During acquisition of right of way for construction of improvements on U.S. Route 176 in Berkeley County, the Department acquired right of way from H.S. Richardson, by Right of Way Easement dated February 16, 1965, under File 8.397.

At the request of an adjoining owner, it was agreed in the negotiation for additional right of way for Road S-45 Relocation that the Department would quitclaim its interest in a strip of land that is a portion of the existing right of way of Road S-45 to adjoining owners. Therefore, a gratis quitclaim deed conveying approximately 0.98 acres of land to Alumax of South Carolina, Inc. and Berkeley Aluminum, Inc. was executed on July 31, 1995.

12. File 8.635 - U.S. Route 176 - Berkeley County

During acquisition of right of way for construction of improvements on U.S. Route 176 in Berkeley County, the Department acquired right of way from H.S. Richardson, by Right of Way Easement dated February 16, 1965, under File 8.397.

At the request of an adjoining owner, it was agreed in the negotiation for additional right of way for Road S-45 Relocation that the Department would quitclaim its interest in a strip of land that is a portion of the existing right of way of Road S-45 to adjoining owners. Therefore, a gratis quitclaim deed conveying approximately 0.83 acres of land to Henry B. Fishburne, Jr. and Donald A. Fishburne, as Co-Trustees, under Article VI of the Will of Henry B. Fishburne, was executed on July 31, 1995.

13. File 42.312A & 42.327A - S.C. Route 101 - Greenville County

During acquisition of right of way for construction of improvements on S.C. Route 101 in Greenville County, the Department acquired right of way from L. Stewart Spinks, Trustee of the Spinks Family Trust, by Condemnation Notice dated December 17, 1993, under File 42.312A and File 42.327A.

At the request of an adjoining owner, it was agreed in the negotiation for additional right of way that the surplus property could be conveyed to the adjoining owner. Therefore, a gratis quitclaim deed conveying approximately .130 acres of land to Enigma Corporation, a corporation organized and existing under the laws of the State of South Carolina, was executed on July 31, 1995.

14. File 42.312A & 42.327A - S.C. Route 101 - Greenville County

During acquisition of right of way for construction of improvements on S.C. Route 101 in Greenville County, the Department acquired right of way from L. Stewart Spinks, Trustee of the Spinks Family Trust, by Condemnation Notice dated December 17, 1993, under File 42.312A and File 42.327A.

At the request of an adjoining owner, it was agreed in the negotiation for additional right of way that the surplus parcel could be conveyed to the adjoining owner. Therefore, a gratis quitclaim deed conveying approximately .310 acres of land to Enigma Corporation, a corporation organized and existing under the laws of the State of South Carolina, was executed on July 31, 1995.
