Good Morning,

Late yesterday afternoon DOA contacted me with the process for making this happen.

There are two requirements to use public property in the manner that Ms. Dolby requested.

1. It must be for the Public Good/Benefit
2. The Public Good/Benefit must be tied to the purpose of the agency that owns the property.

Obviously the program is a public good but it doesn't tie to DEW's purpose.

DOA has proposed that the Office on Aging enter into an MOU with DEW for the building and then the Office on Aging contract the building to Ms. Dolby so that the purpose would align. The DOA believe this can be done at no cost to the Office on Aging other than the leg work of reviewing and executing the agreements. I applaud DOA on this creative solution.
