The Regional Medical Center's president says he's pleased the state's highest court has upheld a program that regulates the construction of new medical facilities and the purchase of new medical equipment.

**Note:** In a statement, Haley spokesman Doug Mayer called the Certificate of Need program "outdated and bad public policy" and said the governor "is determined and will continue working with like-minded legislators to reform a clearly politically driven process that puts additional bureaucracy between South Carolinians and their health care decisions."

The state's two top candidates for governor are clashing over how good a job the state Department of Social Services has done handling cases of child abuse and neglect as the agency's director prepares to address a Senate panel on the issue for the first time.

**Note:** "Gov. Haley appointed Lillian Koller from Hawaii, where she had just been named Public Official of the Year," said Doug Mayer, a Haley spokesman. "Since then, South Carolina has seen a rise in adoptions by 11 percent and a decline in child fatalities by 25 percent. She is committed every day to improving the lives of our children."

**Note:** Rob Godfrey, a campaign spokesman for Haley, accused Sheheen of being a "massive hypocrite" because of his work as a defense lawyer in which he has represented some men charged with criminal domestic violence and child molestation. "He's running around the state talking about family welfare issues, yet he personally made sure that men who attacked women and children spent as little time in jail as possible, and he did it for money," Godfrey said in a statement.
