My name is Engrid L. Grant and I am writing on behalf of my son, Darrin L. Grant, regarding his Medicaid Transportation. Darrin, who is physically and mentally disabled, uses a motorized wheelchair and is a 9th grade student at Dutch Fork High School. We don't have transportation and have been using Medicaid Transportation for years to take Darrin to his medical appointments; after his appointments Transportation picks us up and then takes Darrin to school. Medicaid Transportation is now refusing to take Darrin to Dutch Fork High School after his medical appointments.

On August 21, 2006, I called Spencer Scott, Richland County DSS Transportation Scheduler (803) 714-7536 to schedule a ride for Darrin for September 19, 2006. Mrs. Scott called me back to say that the was scheduled, but Transportation will not take him to school afterwards, that he has to go home. I received no written notification of this decision.

I spoke with Karen Wright (Department of Health and Human Services (803) 898-2655) about Medicaid Transportation refusing to take Darrin to school after his appointments. Mrs. Wright said Transportation is following "Jacob's Law." Mrs. Wright then went on to say that Health and Human Services is waiting to see if the Medicaid vans meet the

State regulations as a school bus.

"The law provides an exception for certain state agencies transporting parents and children together." I have asked the following questions:

- 1) Is Medicaid Transportation exempt from the law, since Darrin and I are transported together?
- 2) What state agencies are excluded from the law?
- 3) What is the exception provided to the state agencies under the law?

The Department of Health and Human Services have not answered my questions because the agency does not know the answers; as for transporting Darrin to his medical appointments and then to school, Health and Human Services says we can use Aiken County Council on Aging or find our own transportation for I. P. T.

If everyone is supposed to follow "Jacob's law," how can Aiken County come to Richland County and provide the same service? Why did Medicaid Transportation wait six years to follow this law?

This abrupt change has created a huge problem for us, because if Darrin can't get to school after his medical appointments, then he misses school, which has already happened. Medicaid Transportation should continue taking Darrin to Dutch Fork High School after his medical appointments.

Governor Sanford, I am seeking your help in contacting the Department of Health and Human Services and the State Attorney General's Office to look into how Jacob's Law will affect Darrin's Medicaid Transportation.

Your time and assistance are greatly appreciated.

Dear Ms. Grant:

Your letter to Governor Mark Sanford regarding the transportation of your son, Darin, to medical appointments and to school has been referred to our agency for response. We appreciate you taking the time to share your situation with us.

The South Carolina Department of Health and Human Services (SCDHHS) recently conducted a review of the impact that Jacob's Law has on non-emergency Medicaid transportation. As a part of that review, SCDHHS received an opinion from the South Carolina Attorney General's office regarding the application of Jacob's Law to providers of Medicaid non-emergency transportation. The Attorney General concluded that:

"when, . . . , the Medicaid transportation provided transports a preprimary, primary, or secondary school student to or from school, we believe Jacob's Law becomes applicable and thus, SCDHHS must comply with its provisions presuming such transportation is provided in a vehicle defined as a school bus pursuant the applicable federal law."

Therefore, Medicaid non-emergency transportation is not exempt from Jacob's Law. While the vans used for Medicaid non-emergency transportation may meet the federal definition of a school bus, they do not meet all standards required under Jacob's Law. Also, according to our reading of Jacob's Law, there are no State agencies that are specifically excluded from the law while transporting students to or from school.


Medicaid non-emergency transportation is provided for beneficiary transport to and from services covered under the Medicaid State Plan. Transportation providers furnish and coordinate non-emergency contractual transportation services to assure beneficiaries arrive to and depart from Medicaid service providers during regular operational hours.

Medicaid non-emergency transportation providers are not required to furnish transportation for beneficiaries to school before or after medical appointments. If the transportation provider is not able to transport the beneficiary to or from school in accordance with Jacob's Law, beneficiaries must provide their own transportation to or from school.

SCDHHS is committed to ensuring that Medicaid beneficiaries receive appropriate non-emergency transportation within the law. If you have any questions, please contact Byron Roberts or me at (803) 898-2795.

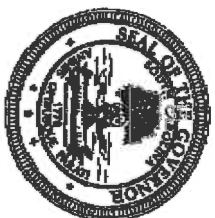

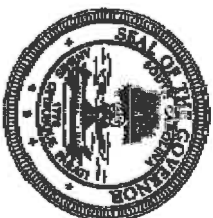

My name is Engrid L. Grant and I am writing on behalf of my son, Darrin E. Grant, regarding his Medicaid Transportation. Darrin is a 9<sup>th</sup> grade student at Dutten Fork High and is physically and mentally disabled and uses a motorized wheelchair.

I am writing for your assistance in finding out from the Department of Health and Human Services how "Jacob's Law" will affect Darrin's Medicaid Transportation, since Medicaid Transportation is refusing to take him to Dutten Fork High School after his medical appointments. Using Medicaid Transportation for years, they have always taken Darrin to school after his medical appoint.

Medicaid Transportation "transports parents and children together," are they exempt from "Jacob's Law"? How can Allen County Council on Aging come to Columbia to transport and take Darrin to school, but our own Medicaid Transportation will not?

We do not have our own transportation to transport a motorized chair and everytime Darrin goes to the doctor, he misses school which is unfair and unjust. Your time and assistance in resolving this matter are appreciated.
