How ARE you doing FINE & in good health I hope. I'm writing in concern of the issues taking place in SCDIC where inmates ARE being ASSAULTED, ATTACKED & DISRESPECTED by SCDIC OFFICERS. My NAME IS ANTHONY JACKSON I AM AN INMATE AT LEE CORRECTIONAL INST.

I WAS ASSAULTED by a OFFICER (Sgt SAMUEL WILLIAMS) AT ALLENDALE CORRECTIONAL INST. ON AUG 17th 2014 IN HAMPTON UNIT A-WING IT WAS ALL CAUGHT ON TAPE. HE LIED & TOLD THE WARDEN & INVESTIGATOR ANTHONY ORR THAT I STOOD UP IN AN AGGRESSIVE MANNER & THATS WHY HE SLAMMED ME TO THE GROUND HARD CAUSING DAMAGE TO MY BACK. I WAS PLACED ON LOCK UP ON AUG 17th & INTERVIEWED BY THE INVESTIGATOR ON AUG 25th. I WAS RELEASED FROM LOCK-UP ON AUG 27th & WAS INFORMED THAT Sgt WILLIAMS NO LONGER WORKS FOR

SCDC. I suffered back pain in my lower back & was going to medical but they wouldn't do nothing for me I got an X-RAY done & it came back negative, but X-RAY only tells there's no damage to the spine but it doesn't tell about nerves, tendons & muscle damage. All medical does is give me ibuprofen & charge me \$10 dollars every time I go so I stopped going. I graduate from A.T.U on May 28th & max-out July 31st My lawyer Mr. Nathaniel Robertson (803) 252-4449 has the video tape & the interview where Sgt Williams was caught in a lie. I need proper treatment for my back & SCDC isn't trying to help me. As you may already know at Institutions all over especially at LEE there's problems with officers & inmates that need to be addressed. They had a

SEE IF YOU CAN HELP MY SITUATION
