You Are Now Ordered By the Governing of Common Law Government by the Law of the Land, BERKELEY COUNTY SCHOOL BOARD DISTRICT AND ALL INCORPORATE DOCTRINE DE FACTO GOVERNMENT Are Here, And Now Ordered to Stand Down, for Order and Governing of the Common Law Upholding and Enforcement of the Law of The Land  
Ensuring Black Natives Natural Universal Human Rights, In Order of the (Drip) Declaration on the Rights of Indigenous People.  
In Compliance With International Law of the Family of Nations.

Notice To :All DE FACTO GOVERNMENT OF INCORPPORATE DOCTRINE, By The Date of May 4th 2015, on or before no  
later than May 4th The Lawful Official Principal Mr Clarence Hawkins will in his Official Capacity report to Sedgefield Intermediate

at his regular scheduled time ready to work in his Official Capacity, wherein he will work in his Official Capacity, With All Rights Reserved  
Without Prejudice, he will receive his regular salary as Official Principal with out any Pay Cut, and within and no later than 90days for the  
Damages and Demotion he sustained Unlawfully against him will be paid in full to him no later than 90 days from the date of May 4th,2015  
by the BERKELEY COUNTY SCHOOL BOARD DISTRICT, who are the responsible parties for his demotion and pay cut of \$19,000.00
