1. Basic SCSEP Grant budget: \$595,195 Federal (local match) \$66,133 Total \$661,328.00
2. 65 slots 14-15 program year, 63 slots program year 13-14. Sixty participants participated during 13-14 program year
3. The SCSEP program provide training opportunities for seniors who are 55 and over and meet the 150% of poverty threshold. The overall goal is to provide unsubsidized employment for participants . Host agencies provide a vital service to SCSEP participants (SCSEP participants receive training in a variety of disciplines while providing a community service). Host agencies have to be non-profit. The SCSEP also work very closely with the local job centers. Limited Competition Grant is one of seven funded nationally. Only a limited number of grantees were eligible based on performance.
4. Goodwill Industries is a sub-grantee and will provide SCSEP computer skills training and quick job opportunities for current SCSEP participants, budget for *Limited Competition* grant is \$63,676.00. through partnerships with adult education as well as the technical education system
5. Counties served by goodwill: Anderson, Cherokee, Greenville, Lexington, Pickens, Richland and Spartanburg (Basic Grant) I
