Thank you for helping the restructuring subcommittee gather information concerning the current deficit situation with the Department of Health and Human Services. After conducting research about HHS's budget issues and after hearing testimony from several HHS employees, I believe the subcommittee would benefit from having the following additional information from fiscal year 2007-2008 through fiscal year 2010-2011: 1) a list of the companies that are not operated by physicians that have contracts with HHS for medical supplies, along with the names of the owners and contact people of the companies; 2) a list of the companies that are not operated by physicians that have contracts to be drug suppliers, along with the names of the owners and contact people of the companies; and 3) a list of sole-source providers for HHS. Please provide these documents to the subcommittee's staff counsel, Bonnie Anzelmo, at your earliest convenience.




