Good afternoon,

The White House Office of Social Innovation and Civic Participation and The Rockefeller Foundation invite you to join us for a convening on *Advancing the Practice of Pay for Success*. The meeting will bring together cross-sector leaders to discuss this innovative tool for achieving greater social outcomes for vulnerable populations at a lower cost to taxpayers.

Since the first White House Convening on Pay for Success in October 2011, several Federal pilots have been launched, over a dozen state and local initiatives have begun, and the first PFS transaction has been closed in New York City. The President's 2014 Budget Proposal requested a breakthrough \$300 million PFS Incentive Fund and nearly \$200 million in new Federal programs. The July 8th convening will build on this momentum with the aim of achieving the following outcomes:

- Foster a common understanding of the Pay for Success model as it emerges at all levels of government, in urban and rural communities, and across a host of issue areas in service to poor or vulnerable populations such as early childhood education, youth development, health care, housing and criminal justice, as well as environmental stewardship.
- Identify ways in which Federal policy can help scale the use of Pay for Success. Specific feedback will be gathered on the President's proposed PFS Incentive Fund.
- Stimulate further development of PFS programming and initiatives in Federal, state and local government.

The meeting will be held in the Eisenhower Executive Office Building (South Court Auditorium) on Monday, July 8th, from 9:00 a.m. - 4:30 p.m. Please note that this invitation is nontransferable.

Clearance: In order to receive clearance to enter the White House Complex, we ask that you complete the form (attached) and return with your RSVP to innovation@who.eop.gov.

Timing: Since the meeting will begin at 9:00 am, please plan to arrive no later than 8:30am to allow time to proceed through security, enter the building, and get seated.
