Dear Governor Haley,

On behalf of Men's Health Network (MHN), I commend your efforts promoting the health of the citizens of your state. The public health system is critical to the health and wellbeing of all, providing health information, surveillance, and promotion of healthy behavior among the general population and high-risk groups.

This year MHN is again performing a survey of state public health departments to determine if they have programs that are designed specifically to reach women and girls, and if there are programs designed specifically to reach men and boys. We understand that there is a significant public investment in women's health, and are supportive of that investment, but we are also concerned that male health sometimes receives less attention and less support. The results of previous surveys were the focus of poster presentations at the American Public Health Association conference and the subject of articles published in professional journals.

Men's health is lagging in many key indicators, including preventable deaths. This is largely due to poor health education, lack of awareness and culturally induced behavior patterns. Despite these obstacles, MHN has found that when men are actively engaged in learning about their health, they are willing and active participants in the healthcare system. In order to address these problems, MHN has worked with government officials at both federal and state levels to promote legislation and practices that encourage healthy lifestyles in boys and men.

The critical nature of the male health crisis is reflected in the recent White House Dialogue on Men's Health, cosponsored by Men's Health Network. Your state's participation in this survey will help us to better serve as a resource for men's and boys' health for the nation, and help us more accurately answer inquiries about the availability of health resources for both men and women.
