

MINUTES OF BUDGET AND CONTROL BOARD MEETING

NOVEMBER 4 1971

The Budget and Control Board met in the Conference Room of the State Auditor's Office at 11:00 a. m. on Thursday, November 4, 1971, with all Board members in attendance. The meeting was also attended by Messrs. P. C. Smith and W. T. Putnam.

The heads of the following Departments appeared before the Board to present their budget requests.

CENTURY SOUVENIR COMPANY OF SOUTH CAROLINA - Mr. Howard Bargreen, President of the Century Souvenir Company of South Carolina, and his attorney Mr. W. F. Prioleau appeared before the Board concerning an alleged claim against the State of South Carolina in the amount of \$136,768.16. Mr. Bargreen claims the foregoing amount as the monetary loss which he suffered as a result of a contract with the Tricentennial Commission.

It was pointed out that a suit had been entered in Federal Court but had been dismissed and the claimant felt that his appearance before the Budget and Control Board was his first step toward an administrative remedy.

The Board accepted the petition as information. (A copy of an accountant's statement has been retained in the Budget and Control Board files and is marked as Exhibit I)

UNIVERSITY OF SOUTH CAROLINA - PERMANENT IMPROVEMENTS - The Board approved a request of the University of South Carolina for the following capital improvements:

Married Student Housing	\$2 350 000
Pickens Street Property Acquisition	500 000
Energy Facility Expansion	550 000
Physical Education Center Expansion	121 000

The Board also approved a request of the University that the total of the Thomas Cooper Library extension be increased from \$8,097,500 to \$9,200,000. The additional amount would be provided by funds originally designated for the purchase of the Federal Building located on Sumter Street across from the University. The Board also agreed that the University could begin construction of the Library during the middle of the year 1972, provided available funds were used. It was clearly stated that the existing schedule of capital improvement bond funds would not be altered to accommodate this project.

WORLD WAR I VETERANS - Mr. Henry Mills advised the Budget and Control Board that he had received a request from the World War I Veterans Organization for an increase of \$1,000 in the contributions which the State makes to that Organization under the Contributions section of the Appropriations Bill. The Board received this request as information.

TAX COMMISSION - The Board was advised of a request by the South Carolina Tax Commission for the trading of two of the Commissioners' cars. However, it was determined that the cars did not meet previously established criteria as set by the Board; and the request was denied.

MENTAL HEALTH COMMISSION - The Board approved a request by the Mental Health Commission that it be permitted to begin construction on a complex known as "Village A" and that the Commission be permitted to finance this construction through the issuance of \$4,525,000 of capital improvement bonds.

BUDGET REPORT - Mr. P. C. Smith presented a tentative draft of the 1972-73 budget based upon the requirements of the various agencies.

This draft showed the normal salary increments of both State employees and teachers, but contained no additional increase for either. This initial schedule showed the difficulty of financing the established services of State agencies without consideration for a percentage raise for teachers or employees.

After much discussion the Board expressed its concern for some increase for State employees and teachers for the fiscal year 1972-73, and Mr. Smith and the budget staff were requested to review the preliminary budget to determine the extent to which appropriations to the various departments would have to be reduced to provide for a 7 percent increase for both teachers and State employees. The Board agreed to meet again when further budget information is available.

There being no further business, the meeting was adjourned at 5:30 p. m.

Pursuant to Mr. Howard Bargreen's request I am writing this explanation for items appearing on Exhibit B, Income and Expense Statement of Century Souvenir Co. of S. C., designated as Sales of Balance of Inventory and Cost of Balance of Inventory. The inventory in question was "the inventory of Century Souvenir Company, consisting of the warehouse on Taylor Street, Charles Towne Landing, and Midlands Exposition Park," which was sold to the S. C. Department of Parks, Recreation and Tourism for the value of the inventory \$108,956.35, per memorandum PRT to Ray Sisk, from Ralph Rabon, dated August 4, 1971.

The total purchases of Century Souvenir Co. was \$337,536.55 of which \$108,956.35 was subtracted in order to be shown as an offsetting item against the sale to PRT for the value of the inventory stated above. The subtraction leaves the remainder of \$228,580.20 designated as Purchases under Cost of Sales.

The sales of Balance of Inventory consisted of the amount of \$108,956.35 of which \$36,318.78 had been paid and the balance of \$72,637.57 is shown as Accounts Receivable PRT on Exhibit A - Balance Sheet.

I hope that this answers any questions which you may have had.
