a separation from Lt. Thomas Cooper whom assaulted
me 6/29/18 slamming my arm in food service flap I want
to press criminal charges against him and have
an permanent separation between us done. these staff are
working with the Gang members setting people up to be killed or
stabbed up there entire staff is...
