South Carolina Gov. Nikki Haley (R) will kick off her reelection campaign later this month with the help of some of the biggest names in the Republican Party. To hear Democrats tell it, she's going to need it. Republicans, meanwhile, aren't outwardly concerned about her chances. "I'm confident she will win a by a bigger margin than 2010," predicted Jon Lerner, a top Haley strategist. So, who's right? The state of play appears to be somewhere in between.

**The State:** Lee Bright announces candidacy for U.S. Senate

State Sen. Lee Bright announced his candidacy for the U.S. Senate on Tuesday, calling incumbent Sen. Lindsey Graham "a community organizer for the Muslim Brotherhood."

**Note:** Bright has had an on-again off-again political relationship with Republican Gov. Nikki Haley. In 2012, Bright was one of two Senators who voted to sustain Haley's veto of \$453,680 for South Carolina's 15 rape crisis centers, arguing the state should not pick and choose which nonprofits receive state funding. Haley then campaigned for Bright during the Republican primary, helping him defeat former state senator John Hawkins.

**Note:** But this year, Haley criticized Bright publicly on a conservative upstate radio show, saying Bright was "with the Democrats" on trying to block ethics reform. Haley plans to formally announce her campaign for reelection on Aug. 26 in Greenville.

Oklahoma Gov. Mary Fallin's office has received Gov. Nikki Haley's signed warrant seeking the extradition of Veronica's birth father, Dusten Brown, to face a charge stemming from his failure to turn over his daughter to her adoptive parents in South Carolina. Fallin's office today confirmed receipt of the warrant and indicated it "expects to release a statement later today." Fallin has up to 90 days to review the request to make sure it "meets the legal threshold for extradition," her office has said.

Oklahoma Gov. Mary Fallin's office says it has received a request from South Carolina Gov. Nikki Haley to extradite the father of a Cherokee Indian girl at the center of an adoption dispute. Dusten Brown was charged over the weekend with custodial interference after failing to appear at a court-ordered meeting in South Carolina, where the adoptive parents live. He turned himself in to authorities in Oklahoma on Monday and was released after posting bond. He refused to be extradited without a governor's warrant.

State Sen. Lee Bright says he is mounting a Republican primary challenge against U.S. Sen. Lindsey Graham next year because South Carolina needs more conservative representation. The Roebuck lawmaker said Tuesday that Graham is too friendly with Democrats. Bright also said Graham spends too much time on international affairs and should be focused more on domestic issues like border security. Graham and Sen. John McCain traveled to Egypt last week to warn that the country may be in for prolonged violence without a dialogue between the military and the Muslim Brotherhood.

State Sen. Lee Bright officially announced his candidacy for U.S. Senate during a teleconference Tuesday. Bright has been vocal about considering a run against two-term incumbent Sen. Lindsey Graham for months. During the conference, Bright touted his voting record during five years in the state senate — a voting history he stated has been commended by conservative leadership and organizations. As a U.S. senator, Bright said he would continue to campaign for an individual's rights to own firearms and an anti-abortion agenda. Bright said he would fight against high taxes and a powerful IRS.

MW is asking a federal judge to dismiss an employment discrimination complaint filed against it by the U.S. Equal Employment Opportunity Commission. BMW Manufacturing Co. said in its response to a commission lawsuit filed in June that the automaker did not engage in illegal employment practices on the basis of race at its Greer plant. In its complaint, the commission said BMW had violated former employees' civil rights by using criminal background checks that had a disproportionate effect on black employees and applicants. The agency said the screenings discriminate against African-Americans, who have higher arrest and conviction rates than whites.

The Citadel has landed a \$1.2 million scholarship grant from the National Science Foundation for students interesting in teaching high school biology, chemistry and math. It's the largest grant of its kind the school ever has received. Lok Lew Yan Voon, dean of The Citadel's School of Science and Mathematics, said the military college had previously applied for the grant three times, refining its application each time. "I guess this time it clicked," he said. Citadel spokeswoman Jennifer Wallace said, this is the largest federal scholarship grant the college ever has received. "The Citadel is committed to fostering science, technology, engineering and mathematical disciplines, and this grant will help us to do just that."

The polls are open and early voting appears light in today's six-way Democratic primary race to fill the state Senate seat formerly held by Robert Ford. Joe Debney, director of the Charleston County Board of Elections and Voter Registration, said he has heard of no problems since the polls opened at 7 a.m. "I didn't hear of any lines except for three or four people deep," he said. "Dorchester (County), from what I understand, has only had one voter so far." District 42 has one precinct — Patriot — in Dorchester County. The rest are in West Ashley, downtown Charleston and North Charleston.

Eastern equine encephalitis cases are rising in South Carolina. The mosquito-borne disease, which can cause twitching, paralysis, depression and death, has turned up in 25 horses across the state so far this year, according to Dr. Boyd Parr, state veterinarian and director of Clemson University Livestock Poultry Health. Seven new cases have been reported in the last week. "These diagnoses are a vivid reminder of the threat that mosquito-borne diseases represent to horses in our state," Parr said. "Maintaining protection by vaccinating horses is very important this year."

North Carolina Gov. Pat McCrory (R) signed a bill Monday requiring photo identification at the polls and eliminating a slew of voting measures designed to protect against voter disenfranchisement. The governor, eschewing a more traditional signing ceremony, announced by way of a YouTube video that he had signed House Bill 589. The bill will require voters to show photo identification -- a driver's license, passport, veteran's ID, tribal card -- beginning in the 2016 elections. Student IDs are not an acceptable form of identification.

The Justice Department and a number of state attorneys general on Tuesday challenged a proposed \$11 billion merger between US Airways Group Inc. and American Airlines' parent company, AMR Corp. Americans remain stingy about carrying credit card balances and are making more of an effort to make timely payments, trends that have helped whittle the rate of late payments on credit cards down to the lowest level in nearly 20 years. The rate of credit card payments at least 90 days overdue fell in the second quarter to 0.57 percent. That's the lowest level since 1994, credit reporting agency TransUnion said Tuesday. The April-June card delinquency rate declined from 0.63 percent in the same period last year, and also was down from 0.69 percent in the first three months of the year.
