Results**MRI OF THE LUMBAR SPINE WITHOUT CONTRAST**

CLINICAL INFORMATION: 63 y/o male with low back pain since he was rear-ended 05/2015; pain radiates into his right lower extremity

COMPARISON: MRI of the lumbar spine dated 04/2007

TECHNIQUE: Multiphasic and multiplanar images were performed through the lumbar spine without the administration of IV gadolinium per protocol.

FINDINGS: Lumbar vertebral body height and alignment are maintained. There is no evidence of acute or chronic fracture or subluxation.

The conus terminates appropriately at L1. Degenerative changes will be detailed level-by-level below:

T12-L2 - Normal.

L2-3 - Mild facet joint DJD.

/ L3-4 - Diffuse disc bulge and moderate facet joint DJD, asymmetric to the right, causes mild left and moderate right neuroforaminal stenosis with possible impingement upon the exiting right L3 nerve root.

/ L4-5 - ~~Diffuse~~ Disc bulge with moderate facet joint DJD contributes to moderate biforaminal stenosis with possible impingement upon the exiting L4 nerve roots.

/ L5-S1 - Diffuse disc bulge and facet joint DJD contributes to moderate biforaminal stenosis

There is a vestigial disc at S1-2.

Review of the paraspinous soft tissues shows some diffuse bladder wall thickening

IMPRESSION

1. No evidence of acute/subacute trauma to the lumbar spine.
2. Multilevel degenerative disc and facet joint DJD has progressed since 2007.
3. L3-4 and L4-5 demonstrates moderate right neuroforaminal stenosis.
4. Diffuse bladder wall thickening which can be seen with chronic bladder outlet obstruction

Results**MRI OF THE CERVICAL SPINE WITHOUT CONTRAST**

CLINICAL INFORMATION: 63 y/o male with neck pain and stiffness since MVC 05/2015

COMPARISON: None

TECHNIQUE: Multiphasic and multiplanar images were performed through the cervical spine without the administration of IV gadolinium per protocol.

FINDINGS: Cervical spine alignment and vertebral body height is maintained. Marrow signal is homogeneous. There is no evidence of acute or chronic fracture or subluxation.

There is a partially empty sella turcica. The visualized posterior fossa contents are normal. The cervical cord signal is normal.

Degenerative changes will be detailed level-by-level below:

C2-3 - mild uncovertebral DJD.

C3-4 - Mild uncovertebral and facet joint DJD with only minimal neuroforaminal stenosis.

C4-5 - Left paracentral disc protrusion just effacing the ventral aspect of the cord and contacting the nerve root. Uncovertebral and facet joint DJD contributes to mild left neuroforaminal stenosis.

C5-6 - Diffuse disc bulge with uncovertebral and facet joint DJD, asymmetric to the left, causes moderate left neuroforaminal stenosis.

C6-7 - Central disc protrusion with uncovertebral and facet joint DJD contributes to mild biforaminal stenosis.

C7-T1 - Normal

Review of the paraspinal soft tissues reveals a few enlarged level 1A lymph nodes to approximately 7 mm

IMPRESSION:

1. No evidence of acute or chronic injury to the cervical spine.
2. C4-5 left paracentral disc protrusion, likely contacting the nerve root.
3. C5-6 diffuse disc bulge with asymmetric uncovertebral and facet joint DJD contributing to moderate left neuroforaminal stenosis.
4. Enlarged level 1A lymph nodes which may be reactive.
