Thanks for your email. I support two bills that address school safety. The first removes the mandate on school districts that only law enforcement may carry weapons in the school. That would allow local districts to decide whom, if anyone, else should be armed in a school. May that would be no one or maybe that would be state constables, retired law enforcement or someone else. The goal is to give districts options. My other bill frees up current funding streams, such as EIA and Lottery money, to be used for school security, including SROs. This too is an effort to increase local control and decision making. Each of these will empower local districts to make better decisions.
