In a question pertaining to Governor McMaster's pro-life veto of funding in the SC State Budget to prevent SC taxpayer money from going to [ genocidal mass murderers ] Planned Parenthood, and his pro-life executive order to ban [ genocidal mass murderers ] Planned Parenthood from the SC Medicaid network,

which prompted a lawsuit by [ genocidal mass murderers ] Planned Parenthood, Post and Courier reporter Andy Shain asked:

Andy Shain: "What does the State gain or lose by halting the Planned Parenthood funding and by paying to defend this lawsuit ?"

These were the first words out of the mouth of pro-"abortion" James Smith in response:

Rep. James Smith: "Henry, this is quite possibly one of the most despicable acts you've done in office. The fact is, the veto and the executive order that you issued was a pure political stunt, that put at risk the health of thousands of South Carolina women, ..."

So James Smith viewed Governor McMaster's pro-life actions to deny genocidal mass murderers Planned Parenthood from receiving SC State taxpayer funds as "one of the most despicable acts" by Governor McMaster in office.

James Smith went on with his criticisms of Governor McMaster, and at one point in his answer said, "This is the difference in this election." While James Smith meant those words in a different way, this four minute segment of the nearly hourlong live televised debate, helps to publicly highlight the difference in this November 6 election for SC Governor between:

[Pro-Life, Pro-Personhood](#) incumbent Governor Henry McMaster  
vs.

[Pro-Death, Pro-Child-Murder by 'Abortion'](#) SC Rep. James Smith

When the time came for Governor McMaster's response, he stood firm on his commitment to prevent genocidal mass murderers Planned Parenthood from

getting even "a penny of taxpayer money from the people of South Carolina":

Governor Henry McMaster: "Well, what we have to gain is that those beating hearts that are eliminated in that place [ i.e., Planned Parenthood's child-extermination centers - two out of the three remaining child-murder centers in South Carolina are operated by Planned Parenthood - in Columbia and Charleston ] will become full adults. That's what we'll have to gain."

After Governor McMaster finished the rest of his response, the Post and Courier's Andy Shain continued to press his shallow dollars and cents analysis, lacking proper consideration for the inestimable value of the sanctity of human life, and a right, reverent fear of God and His commandments:

Andy Shain: "But is it worth the price ?

Governor McMaster gave his immediate heartfelt response.

Governor Henry McMaster: "Yes, it is worth it. This is a matter of life. We have to stand up and say what we stand for. Planned Parenthood has run ads against me. They've endorsed my opponent. That's fine with me, I don't want that endorsement. I want to stop abortions in South Carolina, particularly by an organization that makes its money by promoting abortions. That is not good policy for South Carolina."

Pro-child-murder by "abortion" Rep. James Smith then further responded with his argument against Governor McMaster's efforts to de-fund Planned Parenthood, asserting the Governor's efforts would fail in court and the State would end up paying Planned Parenthood's lawyers. So, in other words, don't bother fighting the fight, because it will cost something if you lose. [ Aren't we Americans thankful the generation of American patriots who fought the American Revolution that began in 1775 didn't have the kind of defeatist ( and disingenuous ) mindset of a man such as Rep. James Smith who is disconnected from the morality of the Bible ( e.g., Exodus 20:13, Matthew 19:18, [KJV](#) ), espousing his shallow, disingenuous dollars and cents analysis, while lacking proper consideration for the inestimable value of the sanctity of human life, and a right, reverent fear of God and His commandments ? ]:

Pro-life Governor Henry McMaster was undaunted by Smith's criticism, and continued to

stand firm:

Governor Henry McMaster: "If this doesn't work, we'll take the next step, but we're gonna eliminate that scourge from South Carolina."
