Compensation Agreement

This Compensation Agreement (the "Agreement") dated this 3rd day of May, 2016 (the "Execution Date"),

BETWEEN:

DNI/WHITE HOUSE of WASHINGTON, DC
(the "Employer")

OF THE FIRST PART

- AND -

GODS CONSULTING LLC of 299 MILLER ROAD APT 125, MAULDIN, SC
29662
(the "Employee")

OF THE SECOND PART

BACKGROUND:

A. The Employer and the Employee entered into an employment agreement (the "Employment Agreement") dated July 1, 2002 as amended.

B. This Agreement does not replace the Employment Agreement but is a temporary supplement to it.

IN CONSIDERATION OF and as a condition of the parties entering into this Agreement and other valuable consideration, the receipt and sufficiency of which consideration is acknowledged, the parties to this Agreement agree as follows:

1. The terms of the Employment Agreement, as amended, are amended by the terms of this Agreement.
2. The Employee will receive compensation as follows: TWO TRILLION DOLLARS AND THREE HUNDRED MILLION DOLLARS, (PAID IN A LUMP SUM, TAX FREE, TO BE DEPOSITED INTO A BANK IN BELIZE, NO REQUIREMENT TO REPORT FUNDS TO THE IRS OR ANY OTHER GOVERNMENT).
3. The Employee's compensation will be payable according to the Employer's policy while this Agreement is in force. The Employer is entitled to deduct from the Employee's compensation any applicable deductions and remittances as required by law.
4. This Agreement is effective from JULY, 1, 2002 until DEC. 23, 2016.
5. Except where the context otherwise requires, the terms of the Employment Agreement will apply to this Agreement.
6. The terms of this Agreement will take precedence over the Employment Agreement unless a new employment agreement or similar agreement is later entered into.
