I was trying to speak to you on your both the numbers but diverted to voice mail. Could you please suggest best time to speak to you. For your clarity, following are important to note:

1. Foreign Minister is same as External Affairs Minister (as we call in India).
2. Chief Minister of Tamil Nadu is based in Chennai (capital city of Tamil Nadu State).
3. As your office decided to not to go to Gujarat now, so arranging a meeting with Gujarat Chief Minister in Delhi will not be feasible. I referred to you yesterday during our call a possible meeting with Mr. Bharat Lal, Resident Commissioner of Gujarat (based in Delhi) who has been closely associated with the Vibrant Gujarat Summit held in Gujarat biannually and is planned from 11-13 January 2015 at Gandhinagar, Gujarat. We can discuss this further.
4. Given the high level business delegation led by Governor Haley, we strongly recommend a meeting with Smt. Nirmala Sitharaman, Minister of State for Commerce and Industry. We are not sure at this moment about her availability. We can speak further on this.
