PETITION FOR REPAIR AND MAINTENANCE OF HEAD LANE

WE, the residents of Head Lane and Oleander Ct, Colleton County, SC are signing this Petition for action to be taken in repair of Head Lane. We have had someone to look into this matter and the County refuses to fix the road saying that the road is a private drive belonging to Fishburne and Company. The definition of a private drive is "a road or driveway on privately owned property, limited to the use of the owner". Fishburne and Company does not own any of the lands on either side of Head Lane and have not had any since the Eighties. In fact, they do not own any lands on Head Lane. Mr. Barnwell Fishburne will not do anything to resolve this matter, stating that he will gladly give the road to the County all they have to do is come to him and ask. County states that they will not consider doing this until Mr. Fishburne brings the road up to code. The County has stated that it was an agreement with Fishburne and other land owners who sell lots that their roads be brought to code and the county would maintain. In researching this there has not been any kind of written agreement to that effect between Fishburne the county or anyone of us who purchased property on Head Lane and Oleander Ct. In fact, there is no stipulation in any of the deeds that it is the responsibility of Fishburne or property owner to keep up this road.

The US POSTAL Service has now refused to deliver mail on Head Lane saying that it is a safety hazard. All residents were required to move there boxes to Honey Lane are not receive mail. Honey Lane is the paved road in off Hwy 15N. This creates a situation whereas anyone that does not live on Head Lane or Oleander Ct. may come down and go thru mailboxes and remove any valuable information, checks, etc.

WE, the residents of Head Lane and Oleander Ct., pay property taxes, be it on land or vehicles. A portion of this monies is to be used for upkeep of roads within Colleton County. We are being denied this. Instead we are having to fork out more monies to have our vehicles repaired because of conditions of these roads, Especially Head Lane.

We asked the County Council to intervene and come up with a resolution in this matter. We are talking about Head Lane, Approx. Eight Hundred Fifty-Two Feet (852 ft.). A copy of this Petition will be forwarded to Governor Haley's office whom we have been in touch with regarding this matter.

We the residents of Head Lane and Oleander Ct are sending out SOS's to get help in getting our road fixed. As of April 6th there will no longer be in mail delivery to us unless we move our mailboxes out to Honey Lane. I have spoke with Mr. Fishburne, whom the County says owns road, and I have spoke with county maintenance and its like there is a pissing match going on. You know what is strange, one of the residents on this road said that at one time the county graded this road monthly.

In Mr Fishburne's behalf his fathers company has not own the land on this road for at least 30 years. The road that is in question is aprox. 928 feet. The county is wanting him to pay \$35,000 to bring up to code and then they will be glad to take over. Huh!!!!

The county isn't concerned with the residents whom have to suffer in the meantime. Oh they will collect our taxes, but they aren't going to use them to help the residents.

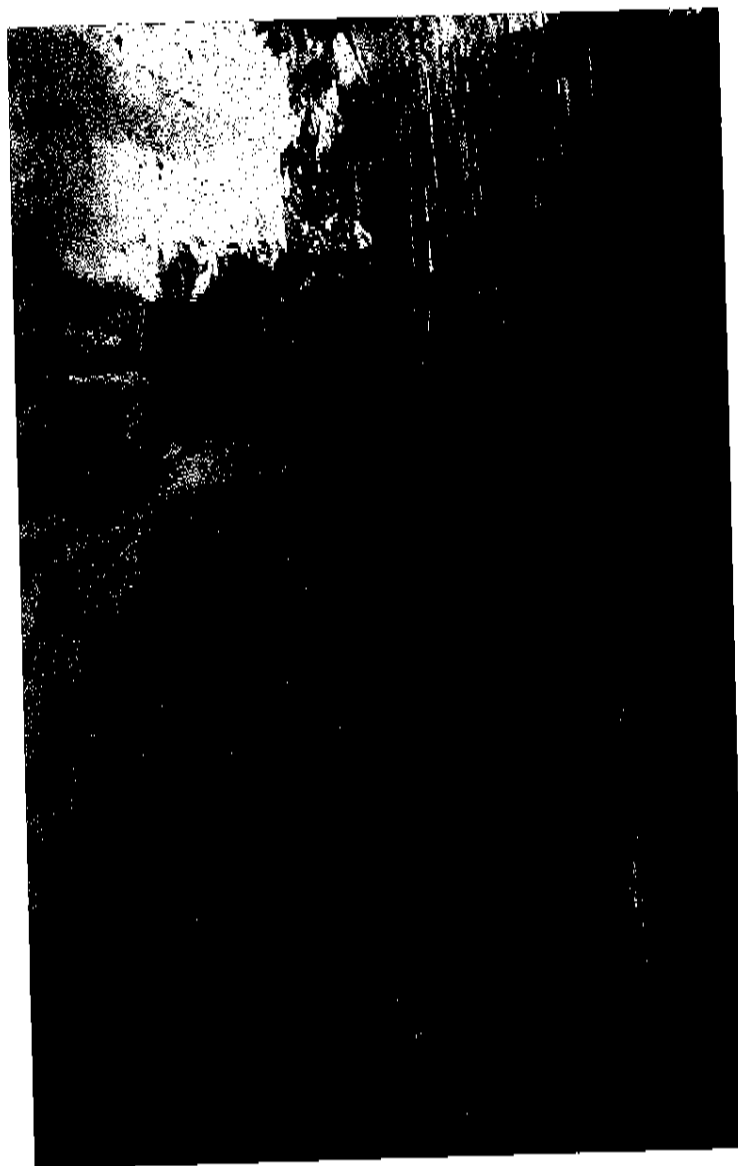
