
Dear Ms. Fouts:

Please find enclosed, South Carolina's request for a three-month extension and modification of Waiver #2040052, from January 1, 2016 to March 31, 2016. This waiver will allow the State to exempt individuals identified as Able-Bodied Adults without Dependents (ABAWDs) statewide from time-limited benefits until the Department of Social Services develops the necessary infrastructure to effectively apply ABAWD compliance and time tracking as required by federal regulation.

Attached is the May 31, 2015, trigger notice from the Department of Labor which shows that South Carolina qualifies for a waiver based on a seasonally adjusted total unemployment rate (TUR) of 6.7%, which is 110% above the previous year's percentage. The period for which the State seeks the extension is January 1, 2016 – March 31, 2016.

STATE WAIVER REQUEST

7 CFR 273.24

6. Regulatory requirements:

Under 7 CFR 273.24(b) individuals are not eligible to participate in the Supplemental Nutrition Assistance Program (SNAP) as a member of any household if the individual received program benefits for more than three months during any three-year period in which the individual was subject to, but did not comply with, the SNAP work requirements. Regulations at 273.24(a) provide that fulfilling the work requirement means: working 20 hours or more per week, averaged monthly; participating in and complying with the requirements of a work program or a workfare program for at least 20 hours per week; or any combination of working and participating in a work program for a total of 20 hours per week.

Under 7 CFR 273.24(f), upon the request of a State agency, the Food and Nutrition Service (FNS) may waive the applicability of the time limit described above for any group of individuals in the State if FNS makes a determination that the area in which the individuals reside does not have a sufficient number of jobs to provide employment for the individuals.

7. Description of alternative procedures:

This request to exempt residents residing in the entire State from the work requirements of 7 CFR 273.24 due to having insufficient jobs is based on the State qualifying for extended unemployment benefits within the past 12 months.

8. Justification for request:

South Carolina is requesting a modification and extension of its existing waiver to exempt residents residing in the entire State from the work requirements of 7 CFR 273.24 due to having insufficient jobs based on the U.S. Department of Labor data that the State qualifies for extended unemployment benefits. This request is for

January 1, 2016 through March 31, 2016. The State does not intend to extend this waiver request beyond March 31, 2016.

26 USC 3304 (Public Law 102-318) allows States the option of providing an additional alternative trigger for the extended benefits program, based on the State's seasonally adjusted total unemployment rate (TUR) for the most recent three months reaching at least: (1) 6.5 percent; and (2) 110 percent of such TUR for the corresponding three-month periods ending in either or both of the two preceding calendar years.

The Department of Labor's Trigger Notice No. 2015 – 20ⁱ shows the State's three-month average total unemployment rate (TUR) was: (1) 6.7 percent and (2) 110 percent of the three-month average for the corresponding period in the first preceding year, making the State eligible for extended unemployment benefits.

9. Anticipated impact on households and State agency operations:

This waiver will provide consistency for households and State agency operations in areas where unemployment remains higher than the national average until the State can develop the agency infrastructure to apply ABAWD compliance and time tracking effectively as required by federal regulation.

This waiver will also provide the opportunity to transition the management of the SNAP Employment and Training (SNAP E&T) program from SC Department of Social Services to the SC Department of Employment and Workforce. As an option for compliance of the ABAWD work requirement, it is in the State's best interest to have the SNAP E&T program firmly established within the new Agency.

10. Caseload information, including percent, characteristics, and quality control error rate for affection portion (if applicable):

The caseload for these areas, as of August 6, 2015, represent 100 percent of the caseload for the state. There are no quality control procedures involved.

11. Anticipated implementation date and time period for which waiver is needed:

The State is requesting a three-month waiver from January 1, 2016, through March 31, 2016.

12. Proposed quality control review procedures:

There are no special quality control procedures needed in conjunction with this waiver.
