The Commission declined to approve a request by the State Superintendent of Education to transfer funds for the purpose of increasing a salary in the department.

The Secretary was directed to send a notice to all departments that no appropriation transfer would be approved by the Budget Commission for the purpose of increasing a salary that had been fixed by the General Assembly.

Lists of proposed salaries for the year 1949-1950 from all State Departments and Institutions were considered by the Commission and all were approved as submitted. In this connection, there was considerable discussion as to the practice of supplementing the itemized salaries in the State Board of Health from Federal Funds. Dr. Ben F. Wyman was asked to appear before the Commission in the course of this discussion. It was agreed that the practice was inadvisable and should be discontinued and it was further agreed that whatever steps were necessary to accomplish this would be undertaken for the next fiscal year.

Members of the Tax Commission appeared before the Commission and requested that the sum of \$12,000.00 be transferred to the Income Division from Income Tax Receipts, the amount of \$9,000.00 to be used to employ additional agents and the sum of \$3,000.00 to cover travel expense of these agents. The Commission approved this request and authorized the Tax Commission to employ these additional agents.

The Commission then adjourned.
