Dear Agency Head, Chief Financial Officer, and Budget Contact:

The State Budget Division has been requested by Legislative staff to identify all federal **Affordable Care Act (ACA)** grants received into the State since the legislation was enacted.

The first attachment above is a “Affordable Care Act Award Actions” report for fiscal years 2010 through 2014 which identifies ACA funds awarded to South Carolina. Using the Tracking Accountability in Government Grants Systems (TAGGS), a reporting tool developed by the U. S. Department of Health and Human Services, we were able to identify ACA grants awarded. However, we were unable to capture all of the federal funding as it is not possible to separate ACA funds from federal dollars spent on the regular operation of a program; particularly the Medicaid program.

- Please review the “Affordable Care Act Award Actions” report to determine if your agency has received any federal ACA funds above what we have identified. To assist with your review, we have included a second attachment which is a listing of all possible ACA sections, U. S. Code sections, and federal program titles under which your ACA funding may have been received.
- If your agency received any federal ACA funds for fiscal years 2010 to 2014 which we have not identified, please use the third attachment, a blank Excel template, to report your data to us.

A response is requested by close of business on **Monday, March 10**.

If we do not receive a response from your agency, we will assume that no federal Affordable Care Act funds were received by your agency.
