The owners of an Upstate restaurant have received South Carolina's highest honor for civilians. That honor, the S.C. Order of the Palmetto, was recently awarded to Allen and Lee Ann Johnston, Duncan residents and owners of Fuddruckers of Spartanburg. The award was in recognition to the couple's "extraordinary work and dedication to the citizens" of South Carolina, Governor Nikki Haley said in the award letter to the Johnstons. In her letter to the Johnstons, Haley said, "It is obvious you have been incredibly effective leaders to those around you. "Through your extensive involvement in civic affairs, you have demonstrated a remarkable commitment to bettering the lives of the people of the Palmetto State, and your contributions will have a lasting impact for years to come," she said. Associated Press: Drug maker reconsidering \$20 million North Carolina factory

North Carolina's governor met Thursday with gay-rights advocates bearing a letter signed by more than 100 corporate executives urging him to repeal the nation's first state law limiting the bathroom options for transgender people. The law also excludes lesbian, gay, bisexual and transgender people from anti-discrimination protections, and blocks municipalities from adopting their own anti-discrimination and living wage rules. The governor "appreciated the opportunity to sit down and deal with these complex issues through conversation and dialogue as opposed to political threats and economic retaliation," his spokesman, Josh Ellis, said in a statement. Some companies are already reconsidering doing business in the country's ninth-largest state.

Note: New Jersey-based Braeburn Pharmaceuticals said it is "reevaluating our options based on the recent, unjust legislation" whether to build a \$20 million manufacturing and research facility in Durham County. The 50 new jobs paying an average of nearly \$76,000 a year were announced two weeks ago.

South Carolina's budget constraints make it unlikely lawmakers will decide what to do about displaying the Confederate flag that was removed from Statehouse grounds last summer, the chairman of the museum that's storing the flag told his board members Thursday. "There's so much pressure on the budget" to put additional money into roadwork and education, said George Dorn, chairman of the museum's newly appointed governing board. "I just don't think they're going to discuss the plan this year." The Legislature voted last year to remove the rebel flag from the Statehouse's front lawn after nine people attending a Bible study were gunned down at a historic black church in Charleston.

Donald Trump may have grabbed South Carolina's 50 convention delegates by winning the state's Republican primary in February. But he might not get to keep them. The GOP front-runner's admission this week that he may not support the eventual GOP nominee has some thinking he's violated the state party's loyalty pledge. Trump signed that pledge — unique to South Carolina and a just few other states — in September as a requirement to get on the state's presidential primary ballot. The oath says that all candidates affirm "I generally believe in and intend to support the nominees and platform of the Republican Party in the November 8, 2016, general election." At the time Trump inked the document, it was seen as a cooling off of the New York billionaire's first run-in with the Republican National Committee over whether he would be embraced as a legitimate contender for the nomination. But earlier this week, Trump fired another shot when he said he might not honor the pledge and continued to speak out about a possible third-party run. He also has let on that he may withdraw his support from the Republican nominee if forces conspire against him toward a possible contested convention in July in Cleveland.

During his several years as solicitor for Georgetown and Horry counties, Greg Hembree was drawn in by municipal officials to "help fix my town." Now a state senator, Hembree has proposed legislation

that adds to South Carolina law "Plan B to address struggling municipalities." The Joint Legislative Committee on Municipal Incorporation determines if an area seeking municipal incorporation meets the state's minimum service standards. If governance fails, "What do you do? This statute sets out a Plan B," Hembree says. The state "lets [municipalities] get born, but has no way to mend them up when they're sick or bury them when they're dead." Hembree's bill (S. 163) is pending in the Senate Judiciary Committee. Sen. Kevin Johnson, a former mayor of Manning, requested that S. 163 be carried over from the Judiciary Committee's meeting March 22. The Senate was on break this past week.

As state lawmakers consider helping South Carolina farmers after last year's rains and floods time is running short for growers to know if help is coming for spring planting. South Carolina Agriculture Commissioner Hugh Weathers tells The Times and Democrat of Orangeburg (<http://bit.ly/1UuU0gL>) that timing now is critical. With lawmakers on break this week, Weathers says the measure will be considered in the Senate next week and says he will stress to lawmakers how critical the help is. The bill would provide a total of \$40 million for farmers to buy seed and plant this spring. Each grower could apply for grants of up to \$100,000 or equal to 20 percent of their loss. South Carolina's farmers lost \$375 million worth of crops during last fall's historic rains.

WACH: Five sentenced for stealing from IRS said 'belief system' allowed them to

Five people have been sentenced to prison after they stole about \$2 million from the IRS. Jefford Henry, Jeffrey Henry, Linda Marie Henry, Makeshia Glover and Bobby McGuire received prison terms for conspiracy to commit wire, mail and bank fraud. The prison sentences range from 121 months for Jeffrey Henry to 46 months for Bobby McGuire. Evidence revealed the five were members of a sovereign citizen group known as the Moorish Nation. In addition to stealing \$2 million, the group attempted to steal \$12 million more by filing false tax returns. The group argued their belief system allowed them to steal from the IRS, the jury did not accept that argument.

Five people claiming to be sovereign citizens found guilty of stealing millions from the federal government were sentenced to a collective 37 years in federal court today. Jefford Henry, Jeffrey Henry, Linda Marie Henry, Makeshia Glover and Bobby McGuire were sentenced for conspiracy to commit wire, mail and bank fraud, wire fraud, mail fraud and money laundering, according to a news release from U.S. Attorney Bill Nettles' District of South Carolina office. U.S. District Judge Mary Geiger Lewis sentenced Jefford Henry to 108 months, Jeffrey Henry to 121 months, Linda Marie Henry to 87 months, Glover to 87 months and McGuire to 46 months. During the trial, evidence showed those convicted were members of the sovereign citizens group the Moorish Nation. The five claimed their beliefs allowed them to steal from the IRS, which the jury rejected.

An attorney is seeking a new trial for a man on death row, saying the prosecutor in the case eliminated potential jurors from the trial because they, like the defendant, were black. Greenwood lawyer Charles Grose said he will file research Thursday to show that 9th Circuit Solicitor Scarlett Wilson has a history of dismissing black potential jurors, the Post and Courier (<http://bit.ly/1RMRyeN>) reported. "The study shows that there's a very disturbing pattern for this particular prosecutor striking African-American jurors," Grose said. Wilson said Grose's findings are untrue and that judges have ruled in her favor when the issue arose during past trials.

A social science expert told a South Carolina judge that Charleston's 9th Circuit Solicitor Scarlett Wilson removed potential black jurors from cases at about seven times the rate she struck white jurors. But attorneys will have to wait until May before continuing with the hearing that could lead to a new trial for convicted killer William O. Dickerson Jr., a black man who in 2009 was found guilty of kidnapping, sexual assault and murder and sentenced to death. Michigan State University School of Law professor Barbara O'Brien offered what she called a pattern in Wilson's jury selection process to Circuit Judge G. Thomas Cooper.

Greenville would become the first location in South Carolina to produce a new military aircraft in its entirety if Lockheed Martin Corp. wins a bid to supply a jet to the U.S. Air Force for the purpose of training fighter pilots. South Carolina is already home to the manufacture of civilian aircraft, the most notable example being The Boeing Co., which makes its 787 Dreamliner passenger jet in North Charleston. But no company now produces an entire military aircraft in South Carolina, according to Deborah Cameron, director of aerospace initiatives for the South Carolina Council on Competitiveness. That would change if the Air Force selects Lockheed Martin to provide a replacement for the aged jet it currently uses to train fighter pilots. That aircraft, the T-38 Talon, has been in service since the late 1950s, and the Air Education and Training Command says it's no longer practical for training pilots in newer, more-advanced aircraft.

Spinx locations are the newest places for electric vehicle drivers to quickly charge up. The Greenville-based gas station and convenience store chain will add chargers to seven of its locations, including five in the Upstate. There will be one "Level 3" electric charger at each participating location. Each charger can charge a typical electric vehicle in less than 30 minutes. Charging will cost a flat rate of \$5.95 plus 20 cents per minute – \$11.95 if a charge were to take 30 minutes. The chargers will be installed and ready to use by May 3, when the company will hold a ribbon-cutting celebration at its 901 Marue Dr. location in Greenville.

Columbia officials now plan to loan nine small businesses more than \$85,000 to help with recovery from the historic storm last fall. Three small businesses were approved for the maximum \$10,000 loans last week after the city's latest round of applications. The man accused in the death of Angie Pipkin will be tried in a different court. Randy Gale Robinson, 48, of Murrells Inlet, is charged with murder and obstructing justice in the 2014 death of Aynor woman Angie Pipkin. He remains at J. Reuben Detention Center without bond. Administrative Judge Larry Hyman recused the 15th Circuit Solicitor's Office from the case because Chris Helms – an attorney who now works for the Solicitor's Office – used to work for the Public Defender's Office, according to a motion filed March 14. Robinson's defense attorney, Morgan Martin, filed a motion in December after Helms, who was previously a public defender on Robinson's case, was hired to the Solicitor's Office.

A realtor who is also part of a local animal rescue organization found Rambo and took him to a veterinary hospital. So far, Rock Hill Police have no leads in the case.

Associated Press: The Latest: Extradition approved for Paris suspect Abdeslam

Belgian judicial authorities have approved in principle the extradition of Paris attacks suspect Salah Abdeslam to France. After two court sessions on Thursday, the federal prosecutor's office said "the transfer is allowed," and added that French and Belgian authorities will "jointly discuss and decide on

the further steps of the transfer." The statement said Abdeslam gave the "clear consent" for the transfer. Abdeslam was captured March 18 in a massive police raid in Brussels. The Nov. 13 attacks in Paris left 130 people dead.

The Brussels attacks have given a boost to the far right in Belgium and beyond, and their anti-Islam language is finding a special resonance after another bloodbath by Islamic State extremists. Just as the Paris attacks that killed 130 people in November reinvigorated the right-wing National Front in regional elections, last week's bombings in the Belgian capital have given radical-right leader Filip Dewinter's Flemish Interest party fresh impetus to re-ignite his group's flagging fortunes. Even in the Netherlands, where one arrest was made linked to a possible future attack this week, fire-brand politician Geert Wilders is using the latest bombings to boost his popularity. It's the result of a potent mix of fear, foreign enemy and a failing security system that has been unable to stop one attack after another.

A gunman shot a Virginia state trooper Thursday at a busy bus terminal in the capital city of Richmond before he was shot dead by two other troopers, police said. Two civilians were hurt, though it was not clear if they had been shot. The trooper's injuries were life-threatening, said Virginia State Police spokeswoman Corinne Geller. The two civilians were expected to survive. Initially, State Police had said in a news release that two troopers were taken to a hospital, but Geller later told reporters that only one had been hurt. Broadcast images showed numerous police cars and heavily armed officers at the scene.

Associated Press: Obama, Xi vow to narrow differences, work closely on NKorea

President Barack Obama and Chinese President Xi Jinping pledged Thursday to cooperate to confront the North Korean nuclear threat while working to narrow persistent differences over cybersecurity, human rights and maritime conflicts. Obama, opening a global nuclear security summit near the White House, also joined leaders of Japan and South Korea in calling for further joint steps to deter North Korea. The display of diplomatic unity came as world leaders sought to ramp up pressure on the insular country's government following worrisome nuclear provocations. "President Xi and I are both committed to the denuclearization of the Korean Peninsula," Obama said as he and Xi sat down for a meeting on the sidelines of the summit. "We're going to discuss how we can discourage actions like nuclear missile tests that escalate tensions and violate international obligations."
