Swati,

A few months ago you worked on a letter for the Governor to send to the FCC in opposition to their preemption of state laws on Government Owned Networks. Would the Governor be willing to send a copy of that letter with a brief cover letter to the Chairman and Vice Chairman of the U. S. House Communications and Technology Energy and Commerce Committee? They are holding a hearing in DC on FCC oversight next week on November 17. This will likely be a topic of discussion. Her letter could be as brief as "I wanted to make sure that you knew of my position on this issue, so attached is a letter that I sent to the FCC earlier this year."

If she is willing to do so, the committee is chaired by Representative Greg Walden of Oregon (R) and co-chaired by Representative Bob Latta of Ohio (R). I understand that AG Wilson is sending a letter to these two and a copy of the amicus brief on which he joined in the appeal of the FCC ruling on the GONs issue.
