Judy I believe was her name also searched Jason's bag on the back of his wheelchair and left ever thing out and unzipped. It is a good thing his aide(not nurse) was there. As he was treated disrespectful by your security. Also please make sure you fix the handicap door coming into your facility, we did report that to you security staff that the outside handicap button to open the door was not working.
