SOUTH CAROLINA OPERATIONS

- Black Water Barrels announced in Jan. 2016 its plan to invest \$3.6 million and create 57 jobs over the next five years in Bamberg County. The company plans to begin production is scheduled in the fall of 2016.
- The company chose Bamberg after looking at option in eight counties in three states.
- To house its operations, the company purchased the 7 acres property and 9,000-square-foot former Zeigler Chevrolet in Bamberg, SC. The company plans to add an additional 12,000 square feet to the building to accommodate a new production line.
- Black Water Barrels will manufacture 53 gallon barrels, made of American white oak. The wood will come from South Carolina, North Carolina and Ohio. The traditional 53-gallon barrel will be targeted to bourbon makers. The others will appeal to whiskey makers, craft distillers, craft brewers, winemakers and cider makers. In the first year, the output goal is 30,000 barrels.

Johnny Williamson

A lifelong resident of Denmark, Mr. Williamson is a successful entrepreneur and businessman whose dedication to improving the quality of life for others in our area through economic development has helped to shape the future of his county and region. Not only is Mr. Williamson the President of Williamson Ginnery in Denmark, he also serves as Board Chairman of the Jackson Companies and President of Carolina Eastern-Williamson. In the past Williamson has served as Managing Partner of Lynchburg Grain, Managing Partner of Carolina Soya and Board Member of Ecogy Biofuels.

Johnny has also spent the last decade in a voluntary leadership role in economic development and industrial recruitment for his community. He has been instrumental in building SouthernCarolina Alliance since its inception. During that time, he has volunteered his time to meet with industrial prospects both domestically and abroad in recruitment efforts, and he has played a critical role in creating the historic multi-county revenue sharing agreement among Bamberg, Barnwell, Allendale and Hampton Counties. His efforts were vital in the recruitment of more than a dozen projects, including Kronotex and Grant Forest Products.

In addition to his service as a Chairman of the Board of Directors of SouthernCarolina Alliance, Mr. Williamson is a Past Chairman of the Palmetto AgriBusiness Council, the former Vice Chairman of the S.C. Bio-Mass Council, a former member of the Executive Committee of the S.C. Transportation and Policy Council, and current member of the Board of Directors of S.C. Bank & Trust, the S.C. Landowners Association and the S.C. Sportsman's Caucus Foundation.

Through his past work with Carolina Soya and Ecogy Biofuels, Johnny Williamson helped to create a market for local soybean producers while establishing the first operational fully integrated biodiesel facility

in the Southeastern United States. Mr. Williamson remains actively engaged in the exploration of cutting edge technologies in other agricultural and alternative energy industry fields.

A true proponent of capitalism and economic development, Johnny Williamson is also an avid outdoorsman who has pursued wild game around the world. His ability to trap alligators for wildlife management has earned him widespread media attention and the nickname, "Alligator Johnny."

Danny Black has served as President and Chief Executive Officer of SouthernCarolina Regional Development Alliance since 2001. A founder of the non-profit economic development organization representing Allendale, Bamberg, Barnwell, Colleton, Jasper and Hampton Counties, Mr. Black's professional experience includes more than three decades in administration, government relations and human resources leadership positions with Milliken & Company and Westinghouse Savannah River Company. A graduate of the University of South Carolina with degrees in Political Science and Public Administration, Black is also a Certified Economic Developer.

He served in public office for eight years as a member of Barnwell County Council, most of those years as Chairman. This was an historic Council, being the first Council elected by single member district, having the first African-American members, the first female members, and the first Republican members to ever serve in Barnwell.

Mr. Black and SouthernCarolina Alliance have been recognized for their economic development accomplishments, including being named the first recipient of the "Individual Initiative Award for Rural Economic Development" given by the S.C. Department of Commerce. Mr. Black has also received the "2001 Leadership Award for Rural Development" given by Commerce, and the Alliance, under Danny's leadership, was given the "1999 Special Recognition Award for Rural Development" at the Governor's Rural Summit. The S.C. Economic Developers Association (SCEDA), a 600- membership organization of economic development practitioners, named him "South Carolina's Economic Developer of the Year for 2005-2006." Mr. Black currently serves as a member of the SCEDA Board of Directors, and as a member of the Savannah River Regional Community Reuse Organization (SRRRCRO), a Congressional appointment

Under Black's leadership, the Alliance landed the largest capital investment projects in the state in the years of 2000 and 2005. The projects, Kronotex USA and Grant Allendale, at the time they were announced, were two of the top ten economic development projects in capital investment in the State of South Carolina in more than twenty years. Since its inception in 1996, SouthernCarolina Alliance has played a critical role in obtaining more than one billion dollars in capital investment and the creation of more than 4,000 jobs in this rural region.
