M I N U T E S

PRESENT: Chairman - C. Edward Poore

Mr. Poore called the meeting to order and Councilman Wright gave the invocation.

On the motion of Mr. Hooper, seconded by Mr. Kinley, Council voted unanimously to approve the minutes from the November 17, 1981 meeting as mailed.

Mr. Dick Thomas representing Video Properties, Inc. asked Council to adopt Ordinance #72 on third and final reading (Transfer of Franchise). On the motion of Mr. Wright, seconded by Mr. Hooper, Council voted unanimously to adopt on third and final reading.

Mr. Bruce Stapleton spoke concerning the allocation of tax dollars between the County and the schools.

Mr. Robert P. Lusk presented Ordinance #74 (Salary & Compensation of Supervisor & County Council) for first reading. On the motion of Mr. Rhodes, seconded by Mr. Kinley, Council voted four (4) in favor and one (1) opposed. Mr. Wright opposed. Mr. Poore stated he was opposed to the ordinance. Motion passed by majority vote.

Mr. Mac Walters informed the Council of the number of bridges needed to be repaired by the County. Mr. Rhodes asked that the county pave only one section of the County's boat ramp behind Shirley's store. Mr. Rhodes introduced a motion to withdraw \$500 from the Audit Account #930 to do the needed paving to the ramp. This motion was amended by Mr. Wright to include Brown Road Ramp and to take an additional \$500 from the account #930 for this ramp (one section only). Motion passed 4 to 1. Mr. Bratcher opposed. Mr. Rhodes stated that if work was not completed in a couple of weeks he would ask for bids to repair the ramp.

Mr. Poore stated that money was available in Account #930 (Audit Account) to pay the medical bills for Ms. Coghlan. On the motion of Mr. Hooper, seconded by Mr. Wright, Council voted unanimously to authorize Mr. Poore to transfer the money for the bill.

On the motion of Mr. Kinley, seconded by Mr. Bratcher, Council voted unanimously to authorize the County Engineer to change the name of Boleman Road to Hattons Ford Extension as requested by the Double Springs Fire Department.

Mr. David Watson presented a request from the EMS Direct to purchase a "Jaws of Life" for the EMS Commission for \$5,635.93. He stated the item was a one source item and this was included in the 1981-82 budget. On the motion of Mr. Hooper, seconded by

Mr. David Watson explained the proposals for insurance for the County. Pilot Life, Prudential, and Blue Cross/Blue Shield were all present and gave a brief description of their policy. On the motion of Mr. Rhodes, seconded by Mr. Wright, Council voted unanimously to accept Pilot Life with \$7000 life insurance plan. Council asked Mr. Jones with Pilot Life to get up figures for the dental plan.

On the motion of Mr. Hooper, seconded by Mr. Rhodes, Council voted unanimously to adjourn at 10:50 a.m.
