One the night of August 20, 2015 a woman received a call that her brother has been hiding in the woods for hours, because three men was hunting him down like a wild animal, the call was to advise the woman to contact her mother and tell her to open the door for her brother because he is very scared and have been in the wood now for approximately 2 hrs, their mom has a medical condition she has been diagnosis with ever since 2005 and being that the mother already took her medication for the night she could not hear her son frantically beating at the back door. The woman then call her dad and advise him that her brother have been in the woods hiding and someone need to help him open the door and call the police. The mom call the sister back and advise she have her son, but before she found him she did notice a car rode though the neighborhood and 3 men was in the car and was pointing what she describe as a gun pointing out the car window she then realize her son was really in fear for his life. She immediatley call 911 and the officer came out and assisted the young man, he deeply expressed his fear to the officer and he said he was scared the 3 men was going to kill him. In the neighborhood where the young man and mother live is a club where the suspects fled to hide from the police the young man did advise the police officers the 3 men where hiding at the club the police didn't even attempt to go to the club and talk with the 3 men, instead they just wrote a police report,(just think about this for a minute a person have called the police in fear for his life, what good is the police if they cant do their job which is protect and serve). When the police left the 3 men came out of hiding the driver of the car became scared because he now know the police is

looking for the them, but that didn't stop them from coming back taunting the young man. The young man and his mother walked back to their home which is 20 seconds away from the club (that will tell how far the the club is from the home about 50 feet). The young man was so scared but he also didn't want these men to come back to his mom house and harm her so he stayed on his step waiting in fear and praying these men didn't came back. After a couple of hours had past indeed the young men came back, this time the driver of the first car didn't come because he had warrants and he didn't want to get caught up in trouble, So this time it was 2 young men and 2 females that came back. The mom then again called her daughter and informed her that they were back and she saw the car dropped one of the guys off around the corner the sister began to cry because she don't know what to do since the police have failed again to protect her brother so she again told her mother to call the police and she did, the brother also had one of the officer cell number and he informed the young man that there was no officers in the area that they was about an hr away. At that time one of the young ladies and

the two men begin taunting the boy and his ex girl friend also showed up to make sure everything was alright. At that time one of the young man grab the ex girlfriend and being beating on her like she was a punching bag, slam her to the ground repeatedly and she began panicking and trying to breathe her eyes began to roll back in her head she began going in and out of conscienous at the same time the young man was being taunted by the young women and other man they began to throw bottles at him and informed him he was next to get a gruesome beating.
