Dorchester County Coroner Chris Nesbit drew a pistol on a neighbor in late August after having a few beers on his porch. He reportedly pointed his pistol at the neighbor who was in a dispute with a repo man for the neighbor's car. On August 25th, SLED opened an investigation, apparently at Nesbit's request. Today, Solicitor David Pascoe charged Nesbit with misconduct in office, and he is expected to turn himself in to authorities tomorrow.

Removal: The Governor may remove a coroner from office upon the satisfaction that the coroner is guilty of malfeasance, misfeasance, incompetency, absenteeism, conflicts of interest, misconduct, persistent neglect of duty in office or incapacity. See Section 1-3-240

Suspension: The Governor may suspend a coroner from office upon the indictment of a crime of moral turpitude. See 8-1-100. Or, the Governor may suspend a coroner from office upon a true bill in the prosecution of an officer who is probably guilty of embezzlement or misappropriation of funds. Or, the Governor may suspend a coroner from office if guilty for misappropriation of funds appropriated by the General Assembly if the coroner was charged with the disbursement of county funds. See 4-11-130.
