The Secretary was instructed to advise the Superintendent of the State Hospital that his request for \$41,000.00 under Section 117 of the 1942-43 Appropriation Act, was denied on the grounds that the expenditure should be made from the 1943-44 appropriation.

The Secretary was instructed to recommend to Dr. William P. Jacobs, Chairman of the State Council of Defense, that Colonel J. D. Fulp be retained in Washington through the month of August at his present salary and that Mr. George W. Speer be retained indefinitely at his present salary of \$300.00 per month.

The Commission declined a request of the Public Service Commission to pay court costs amounting to \$502.51 in the case of the Piedmont and Northern Railroad Company against the Public Service Commission.

The Commission then adjourned.
