The State: State asks S.C. Supreme Court to halt same-sex marriages

Wilson acted after Richland and Charleston counties started accepting marriage license applications from same-sex couples Wednesday, despite the state's constitutional ban against the marriages and Wilson's pledge to defend that ban.

Note: Haley said Wednesday that she thinks marriage only should be between a man and a woman, adding she took an oath to uphold the state Constitution, which bans same-sex unions. But she said the courts left the issue a mess.

Note: "We have to figure out what that is right now," Haley said. "That's the big question of the day for everyone in South Carolina. Where does the rule of law stand after this and where does that leave South Carolina?"

Probate court officials who took the applications in Charleston and Richland counties were responding to a U.S. Supreme Court decision earlier this week.

Note: Wilson's office issued a statement on Monday saying that he sees the fight as one to "uphold our state constitution." Haley's office issued a statement backing Wilson's decision and saying that South Carolina's constitutional amendment banning same-sex marriage should be followed until a court directly rules otherwise.
