Josh:

We have received a request for 78.5 Other Funded Interim FTEs from the Tech Board. These positions are spread primarily among the Technical Colleges. The justification for these positions includes the growth of the schools and need for full-time faculty and staff. Last year, Tech received 69.5 Interim FTEs that were then added during the Senate Finance Committee during the appropriation process.

The Tech Board has included a request for 101.25 FTEs in its FY 2014-15 Budget Request as a part of Decision Package 1748. Before we approve these Interim Positions, I wanted to see if you would consider adding these to the Executive Budget. I have attached a copy of the request from Tech. Mandy Kibler at 896-5316 could answer any questions you have.
