Money is flowing into state coffers at about the same level as it was before the Great Recession, but the per-pupil funding for schools is still in the dumps, Greenville County Schools officials say.

**Note:** Poverty is not a factor in the EFA formula, Haley has said. Her plan calls for funding high-poverty districts, while eliminating several "unnecessary weights and redundant programs," and is designed to "improve equity and allow students to receive a more customized education."

The mayor of Simpsonville was arrested Tuesday on multiple charges including misconduct in office. Mayor Perry Eichor was booked into the Greenville County Detention Center. The warrants said that Eichor, by implied threat, tried to intimidate a municipal judge.

**Note:** Gov. Nikki Haley's spokesman Doug Mayer said once the governor's office receives the indictment they will review it and Eichor will be suspended. Eichor may be removed permanently, pending the outcome of a trial.

A Senate Democrat is again taking aim at the director of the state's social services agency, this time with allegations the agency is committing multiple violations of the law in handling cases involving children. But a spokesman for the agency said Sen. Joel Lourié's facts are wrong. And a spokesman for Gov. Nikki Haley labels the charges as "obviously political" and said Haley remains proud of the director.

A state senator and a child-welfare advocate Tuesday disputed a claim by the state Department of Social Services that fewer children are dying under that agency's care. Social Services deputy director Hanak-Coulter disagreed. Following a report of abuse, caseworkers try to meet with children face-to-face within 24 hours under agency policy, but state law requires only that a thorough investigation begin within that period, she said.
