If we could find a “contact” that she would communicate with, that would be helpful. I would ask the AAA to do an assessment to determine her short term and long term needs. I would also ask the AAA to engage their I&ra staff to look for other resources . I am most concerned about her immediate living condition. That is a tough area for emergency housing and the Dept of Housing has suspended our Rental Assistance Funding. However, there are some monies available thru some area agencies that may could cover some expenses while a long term solution is explored.

It appears that several folks have attempted to assist her over an extended period of time, but I think we need to try to help her. But, we must be allowed to meet with her, assess her needs, and explore all possible solutions.

I called Ms. Wallace and she said there was nothing that I or that no good Keith Summey could do for her. She went on a rant about Sanford and I couldn’t get a word in. She didn’t curse me out, but told me that she was going to the national news to report that no good Keith Summey. She then told me not to call her again before she hung up on me.

There is a history of notes in SC Access on Ms. Wallace since 2013.
