Mr. Neil Pruitt and Nick Williams,

Since 2016 I have written to you requesting the release of my mother Lila T Alston from your facility Pruitthealth in Ridgeway South Carolina.

My mother entered your facility in June 2016 walking, talking and eating and by September 2016 your facility medicinally restrained her to bed and she has not walked again.

This Thanksgiving Holiday I visited my mother. When I visited her every resident was out of their rooms at a worship service or in the common areas of the facility, and My mother was the only one left in her bed and in

her bedroom alone. Her legs have now shriveled up to her chest due to medicinal restraint and neglect.

I am writing to you again. I want my mother returned to me to live out her days with family!!

I have the only Legal POA and your facility has chosen to ignore it and not respond to legal requests from my attorney so that court of law can decide between my document and the internet based document presented to you by my older sister.

To date, my complaints have received a 'no-action' response, and my legal documentation (POA) ignored, and legal representation dismissed.

My mother Lila T. Alston is wasting away in your facility. I want her returned to me to live in my home with family.
