

Columbia, South Carolina
December 5, 1947

The Budget Commission met in the State Auditor's office at 3:00 P. M. on December 5th, to continue its study of Institutional and Departmental Budgets. The State Auditor submitted the totals according to the policies outlined by the Commission at previous meetings. After a few minor changes the result was adopted as the committee's recommendations, as follows:

Estimated General Revenue	\$70,800,000.00
Appropriations Recommended	<u>69,982,710.16</u>
Revenue Margin	\$ 817,289.84

The State Auditor was specifically instructed to include, in the printed comments of the Budget Commission, the following recommendations.

1. That transportation of school pupils be put upon an equitable and sound basis by the General Assembly, and that, until this is done, appropriations for that purpose be frozen at the present amount.
2. That no state employee be compensated from more than one State source.
3. That the daily allowance for travel be for actual expenses incurred, but not to exceed a fair maximum.
4. That the granting of "Expense Allowances", for the purpose of supplementing salaries of State officials, be discontinued.

The Commission received, but took no action on, a request from Dr. Poole, President of Clemson College, for permission to use revenue above the original estimate derived from student subsistence, laundry, infirmary treatment and other such ordinary expenses, to defray cost of these services.

The Commission granted a request from the State Medical College that its Maintenance Revolving Fund be increased by the sum of \$25,000.00.

The Commission then adjourned.
